The title page specifies *Copia recognicionum venerabilis religiosi viri domini Georgii de Gimello curati de Feschier quam Petri Gos notarii Albone receptarum*. However, even though the volume is said to be a « copy », the reconnaissances bear the signature and paraphe of Petrus Gos, with dates in the years 1466-1467. By about 1478, the curatus was Dominus Vuilliermus Barberii, for whom the notaries Petrus des Chaux and Guilliermus Berardi recorded additional reconnaissances, the first of which is found on fol. 31.

The text contains occasional references to earlier documents. At least a few of them have survived at the ACV, now catalogued among the loose parchments and papers pertaining to Féchy, as C XX 22.

(Indistinct notation at the bottom of the page refers to a novo recognitione ? in 1482.)

3v (Lined out) Petrus Veyry burgensis Albone, 26 aug 1466, cense of 2 sols, marginal notations indicate he had paid off this obligation, and, possibly, that the obligation had been sold to the Cortey brothers.

Jaquetus Ressleries burgensis Albane, 26 aug 1466, novo albergamento.

4 Stephanus Cacinat ? (or possibly Cacivat?) de Albana, 01 sep 1466, cum ita sit quod Johannes Monricher ? quondam clericus et burgensis Albane dederit in sua ultima voluntate pro remedio anime sue ..., and the bequest was secured by property (recorded by Mermetus Bassins 27 feb 1405) that is now in the hands of Stephanus.

5 Mermetus Gentil de Beria, 05 sep 1466, property sold to his ancestors by the late Bethodus Michalliens et Leona ? his wife of Feschier.

5v Petrus Leschon de Beria, 30 sep 1466, owed by Peroneta relictæ Perreti Leschon et Petrus dictorum conjugum filius, also from a legacy of quondam Richardum de Quercu quondam de Albana tanquam in parte heredem Humberti Bleis de Feschier... (script is not very clear)

6v Glaudius de Fregdivillaz (=Frigidavilla, Froideville) alias Coaz des Loupz de Ballens, 22 sep 1466, veluti ipse confitens heres et bonorum possidens Francisci Rossel quondam de Feschier, also property previously recognized by Michael de Freigdivillaz manu Petri Fornerii, and a donation to the church of Feschier by Franciscus Rosset predictus manu Nycodi Huguyet.

7v Petrus filius Jaquerii Cuynssins et Johannodus filius quondam Johanneti Cuynssins de Bougier Millon, 23 sep 1466, based on sale by the said Jaquerius and Johannetus Cuynssins to Dominus Vuilliermus Veczat quondam curatus dicte ecclesie de Feschier.

8 Petrus Fontannaz de Villar supra Perrois, 25 sep 1466.

8v Anthonius de Porta de Bougier Millon, 12 sep 1466.

9 Glaudius Mochtet de la Ruynaz sive de la Veis Grangy (Veteri Grangia), 12 sep 1466, based on sale by Hudricus de Veterigrangia to Dominus Vuilliermus Veczat quondam curatus de Feschier.

9v Johannes Martine, 14 sep 1466, previously recognized by Stephanus Martine his father (recorded 11 jan 1432 by Jaquetus Gos quondam notarius Albane).

12 Glaudius de Nemore de Alamant, 18 oct 1466, based on sale by him to the late Dominus Vuilliermus Veczat.

ex legato facto in sua ultima voluntate per Francesiam uxorem Amareti Gazelli filiam quondam Mermeti de Bougel. (See also fol. 39v, a later reconnaissance, 22 apr 1482, for the next curate of Feschier, where the relationships are stated clearly.)

Petrus du Bonz ? habitator de Villar supra Perrois, 01 aug 1467, datis dicte ecclesie per quondam Roletum de Fonte de Feschier.

30v Reymondus Bergier de Feschier, 31 aug 1467, novo abergamento.

31 Ego Aymonodus Jaquinodi de Feschier, quod cum Vuilliermus Guey fiius quondam Roleti Guey de Feschier confessus fuit... recorded by Vuilliermus Alamant presbiter... die tercio nonas aprilis 1331, now Aymonodus makes reconnaissance? (long complicated text, rather messy) , 08 dec 1478, with signature and paraphe of Petrus des Chaux.

32v List of properties directly held by the curate and church of Feschier (not leased to others), in the hand of Petrus Gos.

(There are two folios numbered 33, here identified as 33a and 33b. The folios after this point contain mainly later reconnaissances or other instruments.)

34v Nicodus Garnil (=Garny) alias Baulx de Villart supra Perrois, abbergamentum, 10 feb 1482 Style of the Nativity, Venerabilis Vuilliermus Barberii leases to Nicodus Baulx alias Garnil tanquam plus offerenti.

46 Petrus de la Placiz alias Pissinjat de Perroys nomine suo et Jaqueme eius confitentis filie et heredis pro medietate Glaudie de Bosco de Alamant nominibus (marginal insertion not legible), 13 dec 1488 Style of the Nativity, vigore et pretextu vendicionis et inde recognicionis per eundem Glaudium de Bosco alias facte.

46v (Text is faded and stained, not very clear) Johanneta filia quondam Petri Bartholomey relictæ Johannis Cuydon ? burgensis Albone et Petrus Veyriz burgensis ipsius loci, 25 feb 1489 Style of the Nativity.
