

ACV Fh 129 Seigneurie du Rosey, 1471, commissaire Johannes Challeti

The next later terrier for this Seigneurie is Fi 21, dating from about 1487.

(We were unable to locate this property in the succeeding terrier, Fi 21, about 1487, even though it does contain a reference to a neighboring property with the same description, held by Petrus Bulaz and his wife Margarita, daughter of Petrus Chavornay. It may be that the parcel had become the property of some other Seigneur during the intervening 16 years. Also, with one possible exception, we were unable to locate the neighboring parcels in the present terrier, probably because they were subject to a different Seigneur, such as the Baron of Aubonne. However, comparison with the reconnaissance of Petrus Boulat on fol. 51 for the other half-interest in the same property suggests that it was part of the marriage settlement for Anthoenne Billiard and did not come originally from Vulliermus Reymond. The connection with Petrus Boulat may be through the Chanaz or Chanaux family, maternal ancestors of Pierre Billiard.)
