

ACV Fh 131 Properties subject to the Confraria Sanctus Spiritus de Fechier, 1477-1496, commissaire Petrus Gos.

While the manuscript is in good condition, the foliation is problematic. The original foliation is faintly visible on a few pages, but for the most part is not clearly legible. The original folio numbers xxvi and xxvii are clearly visible, however, for the last two folios of the manuscript. Another old foliation is more clearly visible, but it ends with xxviii on the folio originally numbered xxvii. A third foliation, in Arabic numerals, was supplied by the ACV as part of the preparations for digitization, following the second old foliation, and thus ending with folio 28v. Counting back from the end, where all three foliations are visible, the volume begins with folio i according to the first foliation, but folio ii or 2 according to the second and third foliations.

There is also an index, or more properly, a pair of indices, at the beginning of the volume. The first, with the title “Collige extractus recognicionum, censuum, et possessionum ad opus communitatis de Feschier”, has folio numbers at least as high as 75, with abundant but very faded marginal notations including dates at least as late as 1558. The original entries in this section of the index seem to date from the 16th Century. The second section, certainly older, is damaged, so that the folio numbers of the first two entries, the first of which is obscured complete, are not visible. The first folio number visible in this part of the index is 5, for Petrus and Perrodus Bergier. This set of numbers ends with fol. 26, for Roletus de Crousa, and on the same folio, Anthonius Denanteis or Devanteis. As these items are found at the bottom of a page in the index section, it may be that a final page of the index has been lost.

How do these numbers correspond with the contents of the manuscript itself? The older part of the index clearly corresponds to the original foliation, the reconnaissance for Petrus and Perrodus Bergier is found at fol. 6 following the modern foliation of the ACV, which corresponds to the original folio number 5. The last two items of the old index are found the folio originally numbered 26v, 27v following the second foliation and the modern foliation of the ACV. It appears the original index followed the original foliation of the manuscript.

This leaves the problem of the later, first section of the index, which appears to be an index for some other volume, not yet identified. While there are some tantalizing entries in this section of the index, they are not transcribed here.

For the purposes of this analysis, we show the original folio numbers, in [square brackets] if the number is not visible, followed by the modern foliation of the ACV, shown as (ACV: 1v) etc.
