Previously recognized by Johannodi Rosse de Mollens et deinde Petri et Joannis eiusdem Johannodi filiorum, ex successione eidem confitentus... a dictus Petro et Johanne Rosse alias Chambard... Some parcels are indivis with Michael Bolliet, or Johannes Bolliet, or Petrus Coschet. Witness listed as venerabilis viro domino Francisco de Vioneto (other sources call him Franciscus de Verneto) vicarum de Mollens.

24 Michiel Venard alias Coendoz de Mollens

18 jan 1488, Michael Venard alias Coendoz de Mollens agens in hac parte ... nomine Glaudie eius uxoris filieque quondam Glaudii Coendoz. Previously by Petri et Johannis Chambard alias Rosse, ex acuisito per patrem dicte Glaudie facto a Petri Chambard. One parcel adjacent to Petri Mayor que fuit Anthonii Verney.

26 Johannes Bolliet alias Venard de Mollens

18 jan 1488, Johannes Bolliet filius quondam Michaelis Bolliet alias Venard de Mollens. Previously by Michael Bolliet eiusdem confitentis patrem et Johannem Bolliet eius patrem ... One adjacent to terram Petri Matel alias de Ballens (=Mathey de Ballens) – also spelled Mathei in this document.

27 Glaudius de Freydavilla et Margareta eius uxor filia quondam Petri Coschet habitator ? de Aclens

29 jan 1488, Glaudius de Frigidavilla et Margarite eius uxoris filie quondam Petri Coschet habitator de Aclens. Previously by Perreti Coschet de Mollens et deinde Petri Coschet patris dicte

Margarite Indivis with her sister Perrissona uxore Glaudii Barberii de Ballens. Mention Petrum Rossel alias Chambar de Mollens, thus Rossé=Rossel=Rosset alias Chambard.

29 Glaudius Barberii de Ballens et Perrissona eius uxor filia quondam Petri Coschet habitatoris de Aclens

10 mar 1488, Glaudii Barberii de Ballens et Perrissone eiusdem uxor filie quondam Petri Coschet habitatoris de Aclens. Previously by Perreti Coschet de Mollens et deinde Petri Coschet patris dicte Perrissone.

31 Jacobus Mathey alias de Ballens

22 apr 1488, Jacobus Mathei alias Ballens. Previously by Johannis Chambard alias Rosse de Ballens et deinde Petri eius filii ex empto per eiusdem confitentum facto a Gaudio Nylion de Romanomonasterio qui causam habebat a dicto Petro Chambard alias Rosse.

32 Petrus Lambert de Ballens

29 jan 1488, Jacobus Lamberti de Ballens. Previously by Petri Chambar de Mollens ex acquisito per eiusdem confitentem facto ab eodem Petro.

35 Franciscus Cuvilicti (=Cuvit) de Mollens

29 jan 1489 (!), Francisci Cuvillieti de Mollens. Previously by Johannis Chambard alias Rossel ex acquisito etc.

36v Matheus Brussins de Feschier, 11 dec 1487 Style of the Nativity, de bonis alias per Jaquetum Brussins eius quondam patrem recognitis, et que pridem fuerunt Rleti Michalliens, ex successione dicti quondam eius patris, in tribus morsellis vinee infrascriptis sitis in territorio de Feschier,

47v **Franciscus Gentilis alias Morelli de Beria son of the late Johannis Gentil**

Also another property de bonis que fuerunt Roleti Bernardi douz Martheray parrochie Albone sita in vinoblio de Feschier retro domum que dudum fuit dicti Myrondon? continentem circa unam posam cum dimidia juxta vineam *Jaqueti de Gebennis et Francisci Genti* (these names added later, in a different hand, the space originally left blank) (Franciscus Gentil alias Morel was son of Johannes Gentil who was son of Mermet Pictet alias Gentil. The wife of Mermet Pictet alias Gentil was Peroneta, daughter of Franciscus Morel of Bière.) Mention of a lease by the monastery to the late Thomas Bernardi, the terms of which still apply.

50 **Colletus de Gebennis de Beria et Petri et Jaqueti de Gebennis fratres patrui dicti Colleti.**

02 apr 1493, Colletus filius quondam Colleti de Gebennis de Beria pro medietate ac Petrus et Jaquetus de Gebennis fratres patrui (=paternal uncles) dicti Colleti confitentis pro alia medietate, previously de bonis que dudum fuerunt Johannis Myrondon de Feschier et deinde Francisci Morelli de Beria et successive per Peronetam eiusdem Francisci Morelli filiam uxorem quondam Mermeti Pictet alias Genti, medietatem pro indiviso cum Francisco Gentilis alias Morelli de Beria percipiente aliam medietatem, cuiusdam pecie vinee site in territorio de Feschier loco dicto en laz Chaux continentis circa dimidiad posam juxta vineam Claudii et Stephani Geynyn alias Morelli que quondam fuit **Petri Boulacti de Albona** notarii huiusmodi feudi a lacu et vento, terram Johannis Jaquier que solet esse vinea eciam huiusmodi feudi a juria, et vineam heredum Jaqueti Escuellier a borea, similiar to the preceding reconnaissance.

⇒ It is very tempting to believe that these are the same parties mentioned in later reconnaissances, for (other ?) properties *loco dicto en la Chaux*. By 1507, either the same

Colletus de Gebennis or else heirs of Johannes Morel held property adjacent to Pierre and Jean sons of the late **Louis de Genève of Gimel** that had previously been recognized by Jean fils de feu Mermet Gentil aultrement Morel de Biere, and before that by François Morel, and sold to the said late Pierre de Genève (i.e., one of the uncles of the younger Colletus) by a “cession and remission” by the late Anthoine de Genève aultrement Billiard de Gimel on 08 mar 1552 (notary Guillaume Billiard, very likely also a descendant of Louis de Genève). (See Fh 211, fol. 366, and Fh 9, fol. 114v.) However, the Petrus et Jaquetus de Gebennis mentioned here in 1493 cannot be the sons of Louis de Genève of Gimel, who would not in any case be the paternal uncles of the younger Colletus. Rather, Petrus and Jaquetus should be brothers of the elder Colletus. Nevertheless, it seems more than coincidental that a property at Féchy, originally held by the de Genève family of Bière, would also be held by the de Genève dit Billiard family of Gimel. Unless the reconnaissances are seriously in error, the most likely explanation is still that Louis de Genève was a brother of the elder Colletus. However, another line of inquiry concerns Petrus Boulacti or Boulat, who held a property jointly with Ludovicus de Gebennis alias Reymond and his wife Anthonia Billiard (mentioned in Fh 129, fol. 28v) in 1471. If Colletus *de Gebennis* and his relatives acquired the part previously held by Petrus Boulat, it still seems more than a coincidence that the other part had been and still was held by Ludovicus *de Gebennis* and his descendants.

Mention **Johanneta filia Nycolleti du Bugnyon eius nepte (fol. 54)**.

55 Johanneta filia quondam Nycolleti douz Bugn[ion] de eodem

04 mar 1488, Nycolletus Champion de Gimello tanquam tutor et tutoris nomine Johannete filie quondam Nycolleti douz Bugnion alias Jamin, de bonis alis per Petrum du Bugnion avumpaternum dite pupille recognitis et qui pridem fuerunt Stephani et Johannis Brandis de Bougier Million, ex successione dict eiis patris, $\frac{1}{2}$ indivis with her uncle Claudius. (Thus, Johanneta is daughter of Nycolletus. Nycolletus and his brother Claudius were sons of Petrus du Bugnion. Note that she is not married as of

this date, but verify that her properties are in fact those later in the hands of Johanneta wife of Petrus Vacherand. The name of her tutor seems to prove the identity, however.)

57v Nycolletus Champion de Gimello

04 mar 1488, Nycolletus Champion de Gimello filii quondam Jaqueti Champion de eodem, previously by his father...

59 Nycolletus Reynaudi de Sancto Engendo de Roctires

05 mar 1488, donation to him and his wife Francesia by Hugonet de Mongilliand, previous reconnaissant... Many items, most involve Mongilliand family but relationships not clear.

64v Johannes de Mongilliand de eodem de Roctires (and his brother Petrus)

18 dec 1495, Johannes et Anthonius Ayez fratres habitatores Sancti Engendi de Roctires, again based on Mermeti de Crosa, another purchase.
