

Fh 143 Aubonne a cause du fief de Champvent 1521 Louis Challet

(Problem : are the words nepotis and neptis to be translated as grandchildren, as in classical Latin, or as nephew and niece? Or were these words used in both senses? Can the problem be resolved from other terriers prepared by the same notary? In Fh 146, he uses nepotis as nephew, definitely not grandson.)
