Text says that, in a prior reconnaissance (cuiusdam alternis recognitionis tam per predictum Petrum Cigoen tutorem et administratorem et eo nomine eiusdem Stephani Cigoen et Johannete eiusdem Petri liberorum et quondam Stephane eius uxoris filie quondam dicti Stephani Maior, que dictum Petrum Mayor, in manibus provide viri Guilliermi Berardi de Romanomonasterio... exque legitima successione dictorum suorum patrum...), Pierre Cigoen was tutor for Stephani and Johannete his children by his late wife Stephane, daughter of the late dictum Stephani Maior. There does not seem to be another mention of Stephani Maior in this document—and thus no reason for the word *dictum*—, so it may be that there is an error in the wording. The text needs to be studied more carefully. The history of this parcel might be located in a prior terrier (Eg. Guilliermi Berardi?). There are indications in later terriers of the existence about this time of a Stephanus Monod alias Cigoen, son of Petrus, who had a nephew Petrus Monod son of Claudius son of Stephanus Mayor. This version does not seem compatible with what we find in Fh 144 and elsewhere, since it would appear to leave Stephanus Monod alias Cigoen without a nephew!

For a possible perspective on this problem, see Fh 137, where there are mentions of a Pierre Mayor junior (from Fj 5, this is the son of Mondetus Mayor) whose father-in-law (Latin “socer”) was Pierre Cigoen.

These difficulties would be resolved if “Stephana” was the wife not of Petrus Cigoen, but rather of his son Stephanus. In this case, Stephanus Cigoen would indeed be the uncle (by marriage) of Petrus son of Claudius son of Stephanus son of Aymonetus Mayor. Further, assuming the relationship in Fh 137 is correct, Petrus “junior” son of Mondetus son of Aymonetus Mayor would have married Johanneta, daughter of Petrus Cigoen and sister of Stephanus Cigoen, and would thus be a logical guardian of Stephanus, who must have been still below the age of 25 in 1523.

A reconnaissance recorded by Guiliemus Berardi has been located (ACV P de Mestral I 1507, fol. 326v), but it does not say exactly what was reported here. The two accounts still have to be reconciled.
