(It is noteworthy that the reconnaissance does not indicate how Michael conveyed the property to Claudio. It is tempting to think that Claudio obtained it through succession, upon the death of Michael. Other sources indicate that Michael made a testament in 1517, but the document does not seem to be in the collection of the ACV today. The reference to Aymonetus Pollens is apparently not as simple as it seems. Pollens was indeed the commissaire for the terrier Fj 70 for property subject of the priory of Brussins, but the reconnaissance by Michel Roberti is not found there. Rather, it must have been a reconnaissance for the parents of Guillierma Monestier, who were Guilliermus Monestier and Jaquema de Clauso, or else possibly an earlier generation of the Monestier family. Another peculiarity is the nobility of Ludovica and her late husband. It may be that Ludovica herself came from a noble family, and that the appellation then accrued to her husband as well. A similar property sita in territorio de Germagnyez loco dicto ouz Noerat was held by Claudio Roberti, subject to the Seigneur de Rolle, Fi 55, fol. 398, item (b).)

eiudem Johannete *filios* (text apparently defective ; should be *fratres* ! – from the context, the sale should have been made by Johanneta and her *brother* Anthonius dou Sanctouz, and « Maximianus » would be another brother) Ludovico Billiard fratri dicti confitentis (here again, the text appears defective : Ludovicus Billiard alias de Gebennis probably died not long after 1500, from references in other terriers, and Anthonius Billiard, clearly still living in 1540, seems to have been his grandson. Should the text have been something like, “per predictam Johannetam relictam Glaudii Michaudi ac Maximianum et dictum Anthonium dou Sanctouz eiudem Johannete *fratres Petro filio* Ludovici Billard *patri* dicti confitentis”?) for 52 florins recorded 17 jun 1530 by Discretus. Guillermus Billardi notarius, videlicet quandam peciam terre sitam in territorio Sancti Hengendi de Roctieres sive de Gimel loco dicto ou Chesaulex continentem circa duas posas de ses (=sex ?) posis terre partitis juxta terram Petri Vacherand de Gimel de presenti feudo et ab huiusmodi divisam a juria, terram Petri de Marthereto de Exertines a lacu, terram Glaudii Merminodi alias Bolley et suorum condivisorum dicti loci de Exertines a borea, et terram dicti Anthonii dou Santouz etiam de presenti feudo et ab huiusmodi divisam a vento, cense of 6 deniers. (The cense is owed because of a claim by Nobilis Johannes Costabloz « causam habentem in deductionem novem solidorum et quatuor denariorum Gebennensium veterum alias tam pro ipsa prelimitat pecia terre quam certis aliis rebus et possessionibus quas tenent ipsi Anthonius dou Sanctouz et Petrus Vacherand de predictis bonis debitorum alias per dictos Colletum et Johannetam eos in manibus cuius supra recognitorum. » But as the properties accounting for the remainder of the cense of 9 sols 4 deniers are not listed here, and as there is not reconnaissance for Petrus Vacherand in this terrier, Costabloz must have had a claim only on the 6 deniers. Consequently, there should be a reconnaissance in some other terrier for the remaining portion of the original 6 poses, perhaps with a clearer description of the history of the property.)
