

## **ACV Fh 15 Quernet for Franciscus, Count of Gruyère and Seigneur d'Aubonne, 1543, commissaire Aimé Mandrot.**

Introductory material, showing that Fh 15 and Fh 16 form one vast reconnaissance – technically, a quernet – , exists in the form of two folios of the beginning of a French translation of Fh 15, catalogued as Fh 16bis. At least several folios of Fh 15 are lost, but the surviving text overlaps sufficiently with that of Fh 16bis to provide a satisfactory substitute for the missing text. The question of the relationships and significance of these three manuscripts are discussed in more detail in the analysis of Fh 16.

The date in the inventory of the ACV apparently comes from a much later inscription on the flyleaf of this volume: *Quernet prêté en faveur de Leurs Excellences / Par le Comte de Gruyère Seigneur d'Aubonne, &c. / en l'An 1543.* In 1543, the “Comte” de Gruyère was François, whose brother Michel was the official “Comte” 1539-1554, but Fh 16bis says that François held the seigneurie of Aubonne as a result of a “division” with his brother.

Scattered through parts of the volume are faded marginal notations in a much later hand, such as “Ext. de Bullet cotté A, fol. 4”. Some of these notations are more detailed: “Ext. de Bullet cotté A fol. 12 verso pour cet aultre et suivantz jusques à fol. 217”. Unfortunately, unless the “extract” of Bullet can be identified, and nothing similar seems to be found in the inventory of the ACV, it is not clear whether these notations pertain to the later history of the same parcels, or to an extract of Fh 15 itself, or even to an extract of one of the sources for Fh 15. Apart from a few scattered references to a previous terrier by Braserii (perhaps Fh 137 ?), there seems to be little in Fh 15 that could help to anchor the interpretation in extant, dated sources.

Many of the passages that announce the censiers (generally introduced by the word **Item**, rendered in a heavier Gothic script that contrasts with the lighter, more Italianate script of the main text) have been altered, sometimes more than once, to reflect the situation at some later date, but the changes are often far from clear. Typically, the names of a new set of censiers are inserted (generally, the children or heirs of the original censiers), any irrelevant words of the original text lined out, and the grammatical endings of the remaining words usually but not always altered for consistency. However, these alterations sometimes have the effect of obscuring the original intent, and the placement of the insertions sometimes creates additional ambiguities. At some later date, the analysis might be supplemented by showing the original text separately from the final, altered text.

In fact, there are many mentions of individuals and relationships buried in the descriptions of the individual properties, perhaps worth extracting in the future, but their interpretation will likely remain uncertain due to the lack of any clear chronology. The descriptions of the parcels appear not to have been revised from what was apparently copied from one or more earlier sources.

388v Item, (later insertion by first scribe: Claudium Mayor de Ballens) burgensem ipsius nobilis confitentis (but uncertain lined out notation in the margin), for quadam domo sita in ruat Paccoz juxta domum Claudii Bougnion que fuit Petri, Bertholomei, et Guygonis Coctin a lacu, domum Nycodi Soudans de Ballens et eius consortium a juria, cursum aque de Larmary a vento, et carreriam publicam a borea, (inserted later: que fuit de bonis Michaelis Millo ? ).

(The censiers for the next few properties are in question, the text seems unusually vague.)

390 Item, tres solidos Lausannenses census... per (inserted: Franciscum ? filium) Anthonii filii quo0ndam Petri de Crousa alias de Abondancia de Albona.

391 Item, (later insertion by first scribe: Claudium filium Francisci Raycloz) burgensem prefati nobilis confitentis.

(On fol. 392, there is a change in the script; possibly the second scribe, whose hand has become increasingly fast and irregular, has been replaced by a third scribe, initially with a much neater hand. At this point, the announcements of the censiers are all in the same hand and there are considerably fewer insertions and alterations.)

393v Item, Claudium filium quondam Anthonii Orellyard burgensis ipsius nobilis confitentis (marginal notation: Antonius et Glaudius Orellyard ?) (In the description of the next property, the original text “per quos supra” has been altered, probably in the hand of the first scribe, to “Johannem et Petrum Mugnier”. Various other alterations occur deep in the descriptions of succeeding properties that were originally attributed to the same Claudius Orellyard.)

395 Item, Perronetam filiam quondam N. ? Ressieres burgensis prefati nobilis confitenti. (In the rest of the text, the censier is named once as Nycolletus Ressieres and later as the said Perroneta.)

397 Item, (later insertion: Stephanum filium quondam Stephani de Crosa) hominem liberum et censerium preati domini comitis et suarum, but later in the same item the censier is dictus Stephanus de Crosaz. (In the properties in this group, one mention on fol. 398 of the heirs of Petrus Cornex de Trivillin.)

400 Item, (later insertion: Claudium filium quondam Nycodi Allex) burgensem ipsius nobilis confitentis. (The script changes to that of the second scribe ?, by this point poorly legible.)

401v Item, (later insertion: Guilliermetam filia quondam Stephani Allex) burgensem ipsius nobilis confitentis. (Mentions of Agneta uxor Stephani Monod, filia quondam Johannis Mourier or similar ?, e.g., fol. 402v.)

403 Item, (later insertion: Predictum Johannem filium Ludovici ? Ruyn ? et Agnetis ... ? ) burgensem ipsius nobilis confitentis.

405v (The third scribe returns, with fewer alterations and a much neater hand.) Item, tres denarios Lausannenses census... , **Petrum** (inserted: Gabrielem) filium quondam Stephani Begoz (another insertion: et Gabrielem filium quondam Colleti).

(At this point, the censiers for individual parcels become hard to follow, due to vague text and some insertions.)

413v Item, Petrum Mugnerii alias Lignyouz hominem burgensem ipsius nobilis confitentis.

414v Item, Franciscum filium quondam Claudii Cusin burgensem suum ipsius nobilis confitentis.

415 Item, Petrum Chanesii ? burgensem suum ipsius nobilis confitentis, quadam domo sita Albone in burgo hospitalis juxta domum Francisci Jaconyer que fuit herendum Johannis Mistralis notarii a borea, domum herendum Petri Pellet que fuit **Petri et Mondeti Mayor** a vento, cursum aque de Larmary a juria, et carreriam publicam a lacu, que fuit de bonis Martine ? Bertho... ?

417 Item, Dompnun Renaulderii ? Masson ? burgensis ipsius nobilis confitentis, apparently the previous censier was Mermetus de Intermontibus.

Among other properties, fol. 418: Item, ibidem contigue quadam grangia que per prius fuit **Petri filii quondam Francisci Roberti**, deinde dicti Anthonii Fonjallat, juxta domum Anthonii de Crosa a vento, domum dicti censerii supra confinata que dudum fuit Johannis Mistralis a borea, casale liberorum Petri Got a juria, et carreriam publicam a lacu.

**Vulliermi Robert** a borea, et quandam rueta a juria, et ortum dicti tenementarii qui movetur a domino preposito Montisjovis a lacu, (inserted later: quem tenet Marie filie Stephani Fillietaz).

423v (The second scribe returns, the script sometimes illegible) Item, Bernardum du Char ? burgensem ipsius nobilis confitentis.

425v Item, (later insertion: Perronetam filiam quondam Johannis Bocilley ?, very uncertain) burgensem dicti nobilis confitentis.

428 Item, (later insertion: Johannem de Mont alias Pinjat) burgensem eiusdem nobilis confitentis.

430 Item, (later insertion: Colletam dou Bougnyon) burgensem dicti nobilis confitentis.

(Fol. 431, the third scribe, a neater hand, returns.)

431v Item, Clementum Vidoz burgensem ipsis nobilis recognoscentis.

436v Item, Guilliermum Vuastel de Cossenay ? (written something like Coss.) burgensem ipsius nobilis confitentis.

440 Item, Franciscum filium quondam Henrici Jaconyer alias Galley burgensem prefati nobilis confitentis.

440v (The second scribe returns, poorly legible script) Item, (later insertion: Bernardus Burchat) burgensem ipsius nobilis confitentis.

447v Item, (later insertion: Claudium filium quondam Nycoleti Croset) burgensem ipsius nobilis confitentis.

448 Item, (later insertion: Petrum Dandis, later apparently Dany or similar, de Cabanis supra Veyron) burgensem suam ipsius nobilis confitentis.

448v Item, (later insertion: Discretum Franciscum, Johannem, [et ?] Ludovicum Fonjallat) burgenses.

(Fol. 454, return of the third scribe, text is much more legible.)

457 Item, Claudium Jordanet burgensem ipsius nobilis domini confitentis.

Item, Anthonium filium Johannis Gargii ? (or perhaps Garny ?) burgensem ipsius nobilis confitentis.

458 Item, Jacobum Fuserii burgensem prefati nobilis confitentis.

459 Item, Johannem filium Johannis Curt burgensem suum ipsius nobilis recognoscentis.

460 Item, Nobilem Gabrielem Jalliet burgensem ipsius nobilis confitentis.

(Fol. 461, the second scribe returns, at first fairly legible, but soon very messy.)

465 Item, (later insertion: Claudiam relictam Claudi Soudans) burgensem ipsius nobilis confitentis.

467 Item, (later insertion: Petrum filium quondam Nycodi Coschet) burgensem ipsius nobilis confitentis.

(Fol. 468v, return of the third scribe, more legible, then fol. 472v, second scribe returns, and fol. 476, third scribe again.)

477 Item, Jacobum Daviouz ? de Montherod burgensem ipsius nobilis confitentis.

478 Item, Claudium filium Christofori Maria burgensem ipsius nobilis confitentis.

(Fol. 479, second scribe again.)

480v Item, (later insertion: Nobilem Amedeum Martine) burgensem suum.

(Fol. 489, yet another scribe ?)

(Many individual obligations, not clearly stated.)

510v Item, (later insertion: Petrum filium Johannis Revilliod) burgensem ipsius nobilis confitentis.

(Fol. 522v, possibly the text is in the hand of the first scribe ?, but then a different scribe on fol. 523v.)

525 At the bottom of the page, and continuing to the end, fol. 525v: Item, bampnum, barram, clamam, saysinam, merum mixtum imperium, directum dominium, et omnimodam juridicionem que et quas dictus nobilis confitentis habet super premissis rebus, omnibus et singulis rebus, bonis, et possessionibus superius limitatis.
