

ACV FH 165: Fiefs of Noble Claude Dunant at Féchy, St. Livres, and Gimel 1574, commissaire Jean Barbier.

Notation from about 1725 says that folios 154-175 are missing (in fact, the missing folios are 159-174), and that an extract labeled B had been made in the past, used by Jean Benoit Gignilliat for “une renovation imparfaite” in 1682. The property was sold to LL. EE. In 1723 by Messieurs Fels who had purchased it from the heirs of Imbert Bégoz, successor of the said Noble Dunant, in 1715. The dates of the reconnaissances in this terrier, and of earlier reconnaissances cited in it, reveal something of the chronology of the Dunant family.

The reconnaissances are not particularly detailed, but they are still useful for establishing dates of the censiers. The repertoire missed several reconnaissances and misstated the surnames of several people; these errors corrected below.

Index and summary:

1 Pierre filz de feu Jean filz de feu Claude Mugney (Mugnier) bourgeois d’Aulbonne, 13 may 1574, subject to Claude Dunant. Previously by the said Claude Mugney (Eg. Pierre Gos, 1497), at St. Livres.

6v Jehan et Pierre filz de feu Pierre Pampigniez bourgeois d’Aulbonne, 04 dec 1574, subject to Claude Dunant. Previously by feu Michiel Cacivat bourgeois d’Aulbone (Eg. Pierre Cuynsin, 25 jun 1512, by paternal succession. Property at Aubonne, jx nobles Daniel and Estienne filz de feu Noble Pierre Hugonin de la Tourt de Peil, and jx Françoise Cuynsin femme de Claude Favre de Montherod meuvante du fied et Chappitre de Geneve. Also property previously recognized by Laurent Juget en son vivant bourgeois d’Aulbonne (Eg. Pierre Cuynsin), by maternal succession, jx Michiere fillie dudict feu Laurent Juget relicte de feu Claude Ronget de Saint Livre. Witnesses include Bernard Tripod dict Cottuz and Libere Vionnet de Saint Livre.

14 Michiel filz de feu Pierre Vionnet dict Quiquy, 10 dec 1574, subject to Claude Dunant. Previously recognized by Laurent Juget, and to the said confessant by maternal succession from Estevene fillie dudict feu Laurens Juget, at St. Livres, jx heirs of feu Eg. Michiel Collat. Witnesses Bernard Tripod dict Cottuz and Libere Vionnet dict Quiquy of St. Livres.

20 Michiere fillie de feu Laurens Juget en son vivant bourgeois d’Aulbonne relaissée de feu Claude Ronget de Saint Livre, 07 jan 1575, subject to Claude Dunant. Previously recognized by her father Laurens Juget (Eg. Pierre Cuynsin), at St. Livres,

25v Anthoine fille de feu Laurens Juget relaissée de feu Michiel Germain bourgeois d’Aubonne et Gabriel Vidoz bourgeois dudict Aulbonne son beaufilz, 17 jan 1577, subject to Pierre Dunant. Previously recognized by her father Laurens Juget. At St. Livres, jx Pernelle fillie dudict feu Michiel Germain femme d’Eg. Pierre Curtet notaire et bourgeois de Morges and jx Guillaume Germain femme de Hugue Mouraz. Executed at the house of the heirs of the late Eg. Jehna Regnaud.

31v Jaques Chenevier residant Aulbonne, 27 jan 1575. Previously recognized by Christophle Maria bourgeois d’Aulbonne (Eg. Pierre Cuynsin, 1528), purchased by confessant, at Aubonne, jx Clauda fille dudict feuz Cristophle Maria relicte de feu Eg. Estienne du Martheray, and jx Noble Françoise fillie de feu noble Jaques Demont relicte de feuz Eg. Jehan Valliffin.

37 Guillaume filz de feu Christoffle Maria bourgeois d’Aulbonne, 17 dec 1575, subject to Pierre Dunant. Previously by his father (Eg. Pierre Cuynsin, 1528), by paternal succession, at Aubonne etc. Witnesses include Loys Rolbert autrement Gaddel de Crousaz soubz Feschier.

42v Janne fille de feu François Germain vivant bourgeois d’Aulbonne femme de François Marcier dict Goudin bourgeois d’Aulbonne, 02 jan 1576, subject to Pierre Dunant. Previously by her grandfather Pierre Germain (Pierre Cuynsin, 09 feb 1523, by paternal succession and by partage with her sister Guillaume femme de maistre Hugue Mouraz, and with Pernelle fille de feu Michiel Germain sa cousine femme de Egrege Pierre Curtet notayre de Morges, at Aubonne.

48v Guillaume fille de feu François Germain vivant bourgeois d'Aulbonne femme de maistre Hugue Mouraz barbier bourgeois d'Aulbonne, 02 jan 1576, subject to Pierre Dunant. Previously by her grandfather Pierre Germain etc.

55 Pernette fille de feu Michile Germain vivant cordannier et bourgeois d'Aubonne femme de Egrege Pierre Curtet notayre et bourgeois de Morges, 07 feb 1576, subject to Pierre Dunant. Previously by her grandfather etc.

61v François et Gabriel filz de feu Egrege Estienne Movilliat (Mouvilliat) bourgeois d'Aulbonne, 17 jan 1576, subject to Pierre Dunant. Previously by Pierre Germain (see above), and sold to François Mouvilliat by François Marcier and his wife Jeanne fille de feu François Germain (Discret Loys Coudurier notaire de Nyon resident audict Aulbone, 16 mar 1575), at Aubonne, previously recognized by Claude du Thil d'Aubonne (letter de reconnaissance, Eg. Bartholomey Tripod, 24 mar 1549) and also precedamment by Jaquet Reuginer? d'Aulbonne and his wife Anne, and by Johannod Chesier habitateur d'Aulbonne, to the said confessantz by sale to François Mouvilliat by Maurys du Thil and his wife Jenoz Margel of Aubonne (Eg. Gabriel Begoz, 11 mar 1566), etc. Witnesses Discretz Jehan Croisier de Trivillin notaire et bourgeois dudict Aulbonne et Loys Rolbert aultrement Gaddel de Crosaz soubz Feschier. Includes teneur de vendition 18 apr 1570 rec. Jehan Billiard de Gimel notaire, François Tripod de Saint Livre to feu noble George Dunant, brother of Pierre Dunant (thus bringing the property under the seigneurie of Dunant).

73 Pierre Lalliard bourgeois d'Aulbonne and his wife Loyse fille de feuz Guillaume Planchon vivant bourgeois d'Aulbonne, 21 jan 1576, subject to Pierre Dunant. Sale ? and reconnaissance rec. Eg. Pierre Tripod 13 dec 1567. Jx heirs of Maistre Honnoré Pugnet vivant minister at Aulbonne. With Teneur of the sale of 1567, François de Sivirier had made abbergement to Guillaume Planchon bourgeois d'Aulbonne (abbergement rec. Estienne Mouvilliat and Discret Loys Baudyn commissayre des prothocolles dudict Mouvilliat, 16 jan 1536, and another letter rec. Nycollas Brunier, NOW 13 dec 1567 George Dunant makes new arrangement with Pierre Lalliard and his wife Louyse fille unique heritiere du prenommé feuz Guillaume Planchon.

84v Gabriel filz puppil de feu maistre Jaques Escoffey en son vivant cordannier bourgeois d'Aulbonne faicte par Marie sa mere et tutrice relaissée dudict feu Escoffay, 20 jan 1576, subject to Pierre Dunant. Previously by Pierre Germain (Eg. Pierre Cuinsin, 09 feb 1523), purchased by Jaques Escoffey from François Marcier and his wife Janne fille de feu François Germain (D. Guillaume du Martherey, 22 apr 1572).

90 Hugue du Thil bourgeois d'Aulbonne, 09 feb 1576, subject to Pierre Dunant. Another property that had been subject to Fr. de Sivirier, transferred to George Dunant, rec.J. Billiard, see above for Fr. and Gab. Mouvilliat. Jx one of his properties lequel il tient soubz grace de reachept des hoirs de feu maistre Pierre Vullierens (looks like Vallier, but with additional letters in superscript, thus an abbreviation). Also property purchased from maistre Guillaume Fauzé bourgeois d'Aulbonne tilter ayant de feuz Pierre Vullierens (clear) (D. Jean Croisier notaire de Trivillin 01 aug 1574).

97 Michiel Malliet bourgeois d'Aulbonne, 04 mar 1576, subject to Pierre Dunant. Another relating to the property transferred from Fr. Tripod to George Dunant.

103 David et Jean filz puppilz de feu maistre Pierre Vullierens vivant bourgeois d'Aulbonne faicte par Jaqueme leur mere et tutrice, 03 apr 1576, subject to Pierre Dunant. Another relating to the property transferred from Fr. Tripod to George Dunant.

110v Pierre filz de feu Pierre Cullet et Gabriel filz de feu Jaques Cullet son cousin bourgeois d'Aulbonne, 26 dec 1577, subject to Pierre Dunant. Another as above.

116 Discret Guillaume filz de feuz Egrege Estienne du Martherey notaire et bourgeois d'Aulbonne et de Clauda fille de feu Cristoffle Maria, 26 dec 1577, subject to Pierre Dunant. Previously by Cristoffle Maria (Eg. Pierre Cuinsin, 1528).

121 Jehan du Thil bourgeois d'Aulbonne, 17 apr 1577, subject to Pierre Dunant. Another relating to Fr. Tripod and George Dunant.

126 Pierre Frizot bourgeois d'Aulbonne., 17 jan 1577, subject to Pierre Dunant. Another as above.

133 Jehan Huguet de Biere, 19 jan 1577, subject to Pierre Dunant. Another as above. Mention audict Jehan Huguet confessant appartenant par vendition tant à luy que à Jaques de Genevve, Cristophle Comte et Ysabel Groz-Girard sa femme en leur vivantz dudict Aulbonne (Eg. Jehan Regnaud 03 jul 1568, other names mentioned, situation not very clear.

142 Maistre Jaques Pattherier (Patterier), masson residant Aulbonne, 15 apr 1578. At this point, the seigneur is no longer Claude or Pierre son of the late Anthoine Dunant, but instead, **Samuel son of the late Claude and David, Pierre and Zacharie sons of the late George Dunant.** Another as above, various sales. Witnesses include Humbert Mayor de Ballens.

149v Discret Jehan filz de feu Michiel Croisier notaire de Trivillin bourgeois d'Aulbonne, 06 apr 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously by Pierre Vigoreux de Trivillyn

154v Gabriel et Claude filz de feuz Clement filz de feuz Pierre Vidoz bourgeois d'Aulbonne, 09 sep 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously by their grandfather Pierre Vidoz (Eg. Pierre Cuinsin 10 dec 1493). This reconnaissance is incomplete, lacks approximately the last page. Also, fol. 154v is followed without a break in the text by fol. 156.

Feschier, Crousaz, Martherey, et le Sougey.

175 François Robbert aultement Gaddel de Crosaz soubz Feschier, 17 dec 1575, subject to Pierre Dunant. Previously by Jehan du Fort (Eg. Pierre Gos, 14 nov 1497), purchased by his predecessors.

180v Discret Loys filz de feu Pierre Robbert aultrement Gaddel de Crosaz soubz Feschier, 17 dec 1575, subject to Pierre Dunant. Similar to above but mentions partage with his « condiveurs ». Additional names but difficult to read.

187v Perrod filz de feu Pierre Robbert aultrement Gaddel de Crosaz soubz Feschier à present resident à Martherey, 20 dec 1575, subject to Pierre Dunant. Similar.

193 Gabriel filz de feu Claude filz de feu Pierre Robbert aultrement Gaddel de Crosas soubz Feschier, 13 mar 1576, subject to Pierre Dunant. Similar.

198 Collette fille de feu Estivent Bergier en son vivant de Feschier femme de maistre François Servage bourgeois de Nyon, 12 jun 1576, subject to Pierre Dunant. Previously by feu Anthoine du Sougey mary de ladict Collette (Barthoomey Tripod, 29 oct 1561, and before that by Perrod Bergier de Freschier (Eg. Pierre Cuinsin).

203 Nycolarde fille de feuz Egrege George Challet en son vivant de Trivillin bourgeois d'Aulbonne femme de Discret François Robbert aultrement Gaddel de Crousaz soubz Feschier, 06 apr 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously by feuz Pierre Vigoroux de Trivillin (then subject to Loys de Bectens d'Eschandens) (Eg. Pierre Gos, 02 nov 1585! – obvious error for 1485!), to Nycolarde by paternal succession and by partage with her condiveurs, property at Feschier es Bontz.

208v Claude Favre de Gimel à present residant à Montherod, 12 aug 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously by feu Amed de Ryvaz de Feschier (Eg. Jean Fonjallaz 28 dec 1505), purchased by his predecessors in the discution of Perrod de Ryvaz.

213v Jost Goudard bourgeois d'Eschallens, 19 oct 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously (Barthollomey Trippod 16 nov 1568) by the said Jost Goudard and by his uncle Mayre Goudard, subject to feuz Nobles Jaques Claude George et Pierre Dunant frères, and previously abbergé to Aymonet Agniel de Crousaz soubz Feschier (Eg. Pierre Vignotti 03 feb 1508, subject at that time to noble Loyse relicte de feu noble Loys Montrichier).

Gimel

219 Perrod de Bonnavilla (=de Bonneville) de Gimel, 24 nov 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously recognized (Eg. noble Jaques Hugonin, 14 dec 1514, subject to Pierre and Anthoine Dunant, père et fils) by Jehan Maniglier de Gimel, purchased by his predecessors, indivise with Jehan filz de feu Franceoys de Bonnavilla.

223v Jehan filz de feu Franceoys de Bonnavilla (=de Bonneville) de Gimel, 24 nov 1579, subject to Samuel son of Claude and David, Pierre, and Zacharie sons of George Dunant. Previously as above, indivise with Perrod de Bonnavilla, parentage not noted.
