

ACV Fh 251 Reconnaissances for the hospital of Aubonne, 1283-1503.

This volume, apparently still in the custody of the communal archives of Aubonne, was microfilmed for the ACV, and the digitized images are now available. The inventory of the ACV notes that the contents are in bad condition, but many items are in fact clearly legible. There are modern folio numbers, in pencil, although the folio designated 1 (and clearly marked in old ink at the top of the recto of this folio) begins in the middle of an item dated xv Kalendas Septembris 1330 (18 aug 1330), suggesting that the original folio numbers (Roman numerals) and presumably also the repertorium were added later, at a time when at least one folio at the beginning of the manuscript had already been lost, or else suggesting that the first item is in fact an unlabeled transcript of a fragment.

Selected items are abstracted or transcribed here, pending a more thorough examination. A few extreme dates were found, from 1283 to 1503, although most are in the range of about 1330-1430. The inventory of the ACV is evidently based on a more cursory examination, giving the date range as 1357-1400.

There is also an old repertorium, apparently intact, but not particularly helpful, in that it does not appear to correspond to the main entries, but rather to the names of *some* of the later tenants noted in the margin. In other words, it is a finding aid for the tenants, as of some later but unspecified date.

The description provided by the ACV, however, suggests additional difficulties in interpretation. The répertoire of this “rentier” is at the beginning of the volume, which was microfilmed by the ACV in January, 2002, the original manuscript remaining in the custody of the commune of Aubonne. “Etat général, et spécialement le cahier en fin de voume, en très mauvais état” – but does this imply that there is a separate “cahier” at the end of the volume that was not microfilmed? Or does “cahier” here refer to the physical structure of the volume, perhaps consisting of several sewn “signatures”?

The inventory further notes that there are two folios labeled 11 (this is not strictly correct, the second of these is only a scrap of paper inserted between fols. 11 and 12), as well as a number of blank pages (notably the entirety of fols. 32-45), and that fols 54 and 61-63 are absent, the latter apparently indicated only by entries in the répertoire, but see above. In addition, a number of folios have been torn out, whether purposefully or not, leaving only small fragments of writing.

(This is a very early mention of a Roberti family in this area, but it is far from certain that it is the same Roberti family found at the end of the 15th Century, or how it connects with the others mentioned prior to about 1450.)

Et post modum predicta domini Margareta, Johannes et Jaquetus Marchiandi predicti, de laude etc. prefati Domini Petri etc., quilibet ipsorum insolidum tanquam heredes predicti Jacobi Marchiant emptoris in predicta dicti Nicolai venditoris et Perreti eius filii ad hec consentientis de omnibus in eadem continente, notary Jaquetus de Extertines clericus, 20 oct 1357. Below this, a notation “Item magis, invenies post contra dictos Marchiant verte ix folia ad signum ‡”, directing the reader apparently to 9 folios later, at the sign ‡, which is in fact found at fol. 15 (see below, this is “xi” rather than “ix” folios later, not using “inclusive counting”), and at that point, a further sign directs the reader to even more related entries.

Item, et postmodum predicti Nycolaus presente et predicti Jaquetus et Johannes ..., made a reconnaissance for that obligation, recorded by Jacobus de Lavignier, xii Kalendas Junii 1342 (21 may 1342).

6v (In spite of the fact that the image very definitely shows the verso of the folio numbered at the top, vi, attested by a prominent small, circular hole in the inner margin of the folio, visible in both images, the text on fol. 6v begins in the middle of some other item (“annuatim persolvendos in vigilia Nativitatis Domini. Item, Nycolaus de Presingio de Albone, duodecima denarios Gebennenses super vinea sua sita in predictis territorio et loco juxta vineam predicti Jaqueti de Moura a borea et vineam Vuilliermi et Jacobi liberorum quondam Jaquete Magnynaz de Albona a vento, persolvendos annuatim in dicta vigilia Nativitatis Domini...”), evidently a list of various obligations by individuals. Where is the beginning of this text? The folio is nearly intact, so it does not appear that a reference mark that would connect the text to some other part of the volume has been lost. Two possibilities might be imagined: the text here might be a transcript of an incomplete document, of which only the end has survived – note that there is only a single date at the end, in 1323 – or else that the beginning of this list was on one of the folios that is now missing, and was continued onto fol. 6v, which was at the time still blank. Following the first possibility, and based on the way the text ends, indicating that this was a “letter of sale”, **it might be the case that a number of individuals obtained secured loans from the hospital, all on the same date, on which they owed the annual censuses indicated.**)

The complete transcript of this fragmentary item follows:

As we interpret this list, the secondary “idem” entries interrupt the correct sequence of primary entries, indicating that additional (secondary) entries for that person are to be sought at the folios indicated, while the next *primary* entry, e.g., that for Petrus Vachoz, is to be found on the same (eodem) folio as the preceding *primary* entry, in this example, fol. 4. However, if this is the intended system, it is difficult to follow, because of apparent insertions and alterations.)
