

ACV Fh 4bis Seigneurie of Alamand, 1432-1436, compiled by Roletus Michallini, Petrus Michaudi, and Michael Cristine.

The first two surviving folios, probably 16 and 17, have been torn, resulting in the loss of most of the text. The remainder of the volume is in very good condition. The previous terrier was compiled by Jaquemetus douz Rustio or Ruscio.

The reconnaissances are unsigned, and the entire volume appears to be in the same hand, thus likely a copy. However, a few of the reconnaissances include the name of the notary, of which we found three: Roletus Michallini or Michaliens, Petrus Michaudi, and Michael Cristine, evidently all working simultaneously. The dates range from 1432 to 1436, but most of the reconnaissances refer back to the previous item, “anno quo supra”, and they do not seem to form a continuous chronological series. It may be that the year, when not specified, is not always reliable. There is no way to know how careful the copyist was. If the reconnaissances were not copied in their original order, or perhaps even if they were, “anno quo supra” might not reflect the correct date. The first 15 folios have been lost.
