

ACV Fi 43 Fragments of a terrier for Nobiles Franciscus, Jacobus, et Claudius de Senarclens, 1526-1528, commissaire Ludovicus Challeti.

Based on the highest surviving folio number, the original terrier must have had at least 467 folios, of which only 40 have survived. The identity of the commissaire seems obvious, as he identifies himself frequently in the text, and also from his paraphe, but the ACV inexplicably suggests this fragment may be the work of Jaques Gaudin. From what little remains of this terrier, it is clear that it was a source or predecessor for Fg 275 (also compiled by Ludovicus Challeti) and for the “quernet” Fi 55. In particular, at least some of the descriptions of properties in Fi 43 appear almost word for word in Fi 55, demonstrating that parts of Fi 55, nominally dated in 1543, reflect the situation on the ground in the 1520’s.
