

**ACV Fk 2 Terrier for Amedeus VIII, comes Sabaudie, 1386,
Commissaire Aymo Mercerii of Cluses, and 1403-1405,
Commissaire Johannes Balay, both copied somewhat later.**

What appears to be the original “inner” title of the volume, in a 14th Century hand, evidently that of Aymo Mercerii himself, above the original repertorium (the repertorium is in a later, probably 15th Century hand, certainly well after 1403), calls this volume “Extenta novvillorum ? [=novellorum ?, newly acquired ?] feudorum terre Waudi recepta ad opus Illustris et Magnifici Principis Domini Amedei Comitis Sabaudie per me Aymonem Mercerii de Clusis Gebennensis diocesis dicti domini nostris comitis secretarium et notarium procuratorum curieque ballivie Waudi juratum, a nobilibus et ceteris personis infrascriptis, prout subsequenter scribitur et notatur, quam extentam ad perpetuum rei memoria, signis mei solitis consignam...”, with what is probably intended as his paraphe. Another description of this volume, at the top of the much later répertoire at the end of the volume (alphabetical by place), in French of the 17th Century, is “fiefs Nobles de riere Moudon, Morges et Yverdun, de la Renovation d’Egrege Aymo Mercerii, de l’an 1386”.

The description of the ACV, however, mentions a connection with the 1403 terrier project of Johannes Balay. This is explained, somewhat, by an old notation in the original repertorium, which begins on fol. 2 (the folio number implying, we believe, that there was once an “outer” title page numbered as folio 1, now lost), indicating that fols. 3-60 were copied into, or updated by, Balay B, fol. 97. The most specific indication is in the second item of this repertorium, referring to the section for Corselles within the holdings of the Château de Bavois, “Corcelles supra Chavornay, folio xxix”, with the insertion : “a esté du despuis recogneu es mains de Balay, en l'an 1403, comme en son livre et grosse f°. iiii^{xx}xvii. B.” It is not yet known whether the corresponding terrier of Balay actually copies the text from this part of Fk 2, or whether it contains a complete revision of the same material, brought up to date for the situation in 1403. The “B” volume is believed to be ACV Ab 2, and the repertorium for that volume does indeed indicate a reconnaissance for Nobilis Bernardus de Glerecy condonus Baoyes beginning at fol. 97, but that is clearly a generation later than the one given here in Fk 2.

A further notation on the repertorium of fol. 2 shows “Balay 29 B” next to the index entry for Nobilis Johannes de Gumoens, dominus de Biolley, and “Balay vi^{xx}xix A” (that is, fol. 139 in the “A” volume of Balay) next to the entry for Domina Isabella de Vulliens. Thus, the reconnaissance for Isabella here in the A section (below, fol. 81) was updated by Balay, although the “A” volume is apparently lost or at least misplaced today, apart from two partial copies, today known as AEF Grosses Quernet 140 and 142, which, however, do not contain the reconnaissance of Isabella de Vulliens, and besides, do not seem to preserve the original folio numbers from the missing “A” volume. (See Philippe Champoud, 1963, *Les droits seigneuriaux dans le Pays de Vaud, Bibliothèque historique vaudoise*, tome 36)

The annotations of the 17th Century in Fk 2 are quite detailed, listing neatly in the margins the major topics and rents, as well as the individual censiers in most sections. There is a notation about a misplaced section at fol. 186, that should have been fol. 25. On the original fol. 24, there is no indication that anything has been misplaced, and the text continues without a break or change of script from fol. 24v to (the original) fol. 25. In the original repertorium, however, the last entry says “Morges, Lonay, Eschichens etc. vide seqq.”, meaning, presumably, *beyond* the highest folio number indicated in the rest of the repertorium, 166. There is also a notation about this situation at the very end of the terrier.

These irregularities led us to notice an additional set of original ? folio numbers. The ACV numbered all the folios (recto and verso) at the bottom of each page, in preparation for the “digitization” project. If we look at the original numbers, we can learn something further about the origins of Fk 2. The original, 14th Century hand continues from fol. 3 to fol. 170 (written viii^{xx}x). Within folos. 3 through 170, however, there is a section of 11 folio numbers that are repeated in error, i.e., 80-90, followed by another 80-90, this error occasioned by the existence of two different ways of writing 80, lxxx and iii^{xx}i – and this error is not unique in the terriers and notarial registers of Vaud! Following fol. 170, the next folio is in a typical 15th Century hand, and this folio is the one numbered first xxv, and later, with the annotation about transposed pages, 186. The ACV treats this folio as 186 as well. The folio numbers continue from this point with the two sets of numbers, xxvi and 187 to xxxi and 192, but at this fol. 192 (ACV’s number), the script changes to an earlier hand. The reconnaissance at that point is dated 31 jan 1403, the commissaire is Johannes Balay, and in the margin, “1403. à l’instance de Jehan Baley.” The double numbers continue, with the same hand and still in 1403, to fol. xxxvii, which lacks the other number, which should have been 198. The ACV treats this as fol. 198. The folios continue, xxxviii at the top, the same hand, ACV number 199, to xlii, ACV number 203. This is followed by blank folios the ACV has numbered 204-210v. Then we encounter old folio number iiiⁱⁱ, ACV 211, in the later (15th Century ?), more relaxed hand, still dated in 1403, and the foliation continues to fol. xxiiii, ACV 231, the final folio of the terrier.

The correct sequence, then, appears to be (using the ACV’s numbers) : 3-170v for the section originally compiled by Aymo Mercerii in 1386, then (the section originally compiled by Johannes Balay) folos. 211-231v, then 186-203v. For our purposes, we follow the original foliations in two sections (3-170v for Mercerii, then 4-42v for Balay), with the ACV numbers in [brackets] as necessary.

With the demarcation of two separate sections, the second originally compiled by Balay, questions arise that will need further study: What is the relationship, if any, of the second section of Fk 2 with its first section? What is the relationship of the first section of Fk 2 with the surviving terriers of Balay? For that matter, what is the relationship of the second section of Fk 2, containing copies or paraphrases of reconnaissances recorded by Balay, with the surviving terriers in his own hand?

First Section (1386, compiled by Aymo Mercerii) :

3 Castrum de Bayoys (=Bayoes, Bavoys, Bavois), **Nobilis vir Dominus Estardus** (in the original repertorium, this name is written *Æstardus*, or possibly *Æscardus*) **de Montesangino** (repertorium : **de Montesanguino**) miles, dominus de Montet in Burgondia dyocesis Bisuncinensis, with consent of Domina Ysabella domina de Joczel and Domina Beatrice, “consorts” (evidently in the sense of parties having a joint, legal interest) of Domini Henricus de Glery, daughters of the said Estardus by his wife Nobilis Domina Raynauda de Joulz, 16 mar 1386 Style of the Nativity, no closing phrases or witnesses, evidently understood to be continued in the next item: (The situation is described as follows by David Martignier and Aymon de Crousaz in their Dictionnaire historique, géographique, et statistique du Canton de Vaud (1867, p. 69, article on the seigneurie de Bavois : 1358 : Estard de Montsaugeon (des sires de Monnet, vicomtes de Salins) est devenu seigneur de Bavois par son mariage avec Reynaulde de Joux. – Henri de Gléresse (Ligrez) épouse Béatrix de Montsaugeon, fille du précédents, et devint seigneur de Bavois. Son fils Bernard prête reconnaissance de la terre de Bavois en faveur du duc de Savoie, entre les mains du commissaire Balay, 1404.)

38v Alia recognicio **prefato Domini Estardi (or Escardi)**, 16 mar 1386 (anno, indicione, et die quibus supra), witnesses Johannes de Yens domicellus dyocesis Lausannensis, Aymonetus Sappin de Pontallia dyocesis Bisuncinensis, Thomas Mely de Berno, et Robertus de Bons de Clusis Gebennensis dyocesis, no signature or paraphe. (Additional fiefs he held, some from his father Richardus, others more recently purchased at Pampigny, Luxurier, Escleppens, etc.)

61 **Nobilis Johannes de Gumoeyns (=Gumoens)** dominus castri de Byoley Magnyoz, 19 aug 1386, properties at Biolley, Corevon, Ogens, Oppens, etc., witnesses Nyodus Avena domicellus, Johannes Walacret, Robertus de Bons, et Johannes de Cusson clericus, no signature or paraphe. (Marginal notation in the repertorium : Balay 29 B. This corresponds to a reconnaissance in Ab 2, the “B” volumes of Balay’s terrier of 1403, with a reconnaissance for Franciscus de Gumoens beginning at fol. 29.)

(Folio 90, written lxxxx, is followed in error by folios 80-90, written *iiii^{xx}*, *iiii^{xxi}*, etc. We designate this incorrectly numbered section as fols. 80B-90B, and present them in the order they appear in the manuscript. Some of the manuscript folio numbers for this section were amended in the 17th Century hand, 2/80, 2/81, etc.)

heredem meam". Elle assigne ce cens sur tous ses biens et entend qu'il puisse être rédimé pour 60 sols) sub dicto homagio per dictam Dominam Ysabellam et suos ut promictitur supportando, videlicet homines, census, tallias, res, possessiones, et jura que inferius particulariter designantur, (Marginal notation in the repertorium : Balay 139 A, evidently referring to the A volume of Balay's four volumes of 1403. However, the reference does not seem to correspond either to ACV Ab 2, labeled as the "B" volume, or AEF Grosses Quernet 136, labeled as the "A" volume. The extensive fief is essentially the same one described in Ab 6 (1358-1361), Fn 5 (1379), Fn 8 (1399-1405), Fn 9 (1403), Fn 27 (1459), and parts of Fn 76 (1541) and Fn 194 (1763-1764), notably in these terriers for sections concerning Chavannes-sur-Moudon.)

(In effect, this reconnaissance is divided into three sections: the first for the fiefs held by Isabella, beginning here; the second for those held by her sister Margareta (fol. 127), and the third for Isabella's son Johannes de Fernay (fol. 147v). However, there are no closing formalities, witnesses, or signature. Given the several blank pages, it is possible that this reconnaissance was a work in progress, never finalized.)

Petrus de Wliens domicellus viginti duos denarios obolum Lausannensium novorum. Item, duodecim denarios Lausannensium novorum census solvendos prout supra in quibus eidem Domine Ysabelle et suis annualiter tenetur idem Perrodus... Evidently, the lesser nobles also collected censes on some properties, and a portion of what they collected was then to be paid to Ysabella.
