

ACV FL 111 Quernet Fragment, seigneurie of Lugnorre, circa 1380-1420.

Abstracts prepared by John W. McCoy (RealMac@aol.com) © 2020.

This item is a fragment of a quernet or rentier for a noble fief, covering parts of the Vully region. It consists of folios numbered 186-243v, but contains no dates. Markings on this fragment include designations C, N° 57, and N° II.187 on the first folio. The inventory of the ACV reports that it was formerly held by the Tribunal de Justice for the district of Avenches. The name of the noble who held the fief, as well as the name of the fief itself, are not stated. There are no indications of the identity of the commissaire, apart from what may be a badly faded paraphe located – for no apparent reason – at the bottom of fol. 200. However, the text includes the names of many tenants. There are also many marginal notations (most, however, are faded, lined out, or otherwise very difficult to read) that give the names of later tenants of individual parcels. The document is written on laid paper. We have not yet discovered a watermark.

In order to make this fragment useful, and in hopes of establishing its approximate date and the identity of the noble who held the fief, we have extracted the names of the tenants and other identifying information that might allow us to make a logical connection with the other surviving terriers for the same area – a nearly complete transcript. Some of the tenants are the grandparents of tenants named in FL 81 (dates mostly 1445-1447), so it seems likely that FL 111 dates from around 1380-1420, but definitely during the lifetime of Roletus Gaschet, apparently the only one of that name in the area in the early 15th Century, who died in 1447 or 1448. His father Nicoletus Gaschet had died in 1416, and we found at least one marginal notation that Nicolletus Gaschet was a *later* tenant, perhaps placing a further constraint on the date of FL 111, as well as another marginal notations indicating that one parcel was *later* held by the children of Johannes Gaschet, brother of Nicoletus, who died about 1425. At least some of the individual properties mentioned in FL 111 are found in FL 81 (circa 1425-1428) as well, at that time held by Humbertus bastardus de Sabaudia, who had acquired various fiefs in the area in 1403, which remained under his control until his death in 1443. The seigneuries involved, presumably those of Lugnorre and/or Cudreffin or of some noble fief within them, had been held by the Grandissono family since 1311, then, after the sensational death of Otto de Grandissono in the famous duel with Girardus de Estavayer in 1397 (Otto had been wrongly accused of poisoning Amedeus VII de Sabaudia), their fiefs were confiscated and returned to the jurisdiction of Savoie. During the tenure of the Grandissono in this area, the seigneurie of Lugnorre, in particular, was sold to the counts of Neuchâtel, but reserving the right of redemption, which seems to have been taken over by the duke of Savoie along with the other possessions of Grandissono, and thus it appears that the seigneurie of Lugnorre as well had reverted to the domain of Savoie about 1397, to become part of the apanage of Humbertus de Sabaudia in 1403. However, the intervening years were anything but peaceful, as the previous duke Amedeus VII had died in 1391, followed by a bitterly disputed regency that bordered on anarchy, until his son Amedeus VIII, born in 1383, came of age. It seems unlikely that the project of compiling a terrier for the regency of Savoie would have been undertaken between 1397 and 1403. Before 1397, a terrier or quernet might have been requested by either Otto de Grandissono or the count of Neuchâtel. After 1403, a terrier or quernet would likely have been among the priorities of Humbertus de

Sabaudia for the administration of his new domains. We may be able to find echoes of this period in FL 81 or FL 82 that might help to establish the sequence of any of the lost terriers.

At least some of the marginal notations mentioning later reconnaissances in FL 111 correspond to reconnaissances in FL 81. (We note that the existence of these notations suggests that the more authoritative sources of FL 81, the original reconnaissances summarized or paraphrased in FL 111, were already unavailable when FL 81 was being compiled.) However, due to the passage of time, the descriptions of these properties often do not match closely. At least it is now clear that FL 111 (or the original volume from which these pages were taken) must have been used in the preparation of FL 81, or of some closely related terrier. With this discovery, we can assign FL 111 to the seigneurie of Lugnorre, probably to be understood as a quernet for Humbertus de Sabaudia or one of his predecessors in this seigneurie.

Another approach to establishing the approximate date of this fragment is to locate references to the people named here in other records, such as ACV's série C, Parchements et Papiers from the medieval period, and the few registers of the notaries in the districts of Avenches and Payerne that have survived from the early 15th Century. So far, we cannot report much success from this line of research, apart from the fact that Borcardus de Adventhica, mentioned as deceased (below, fol. 189), died before June, 1381. However, one terrier of interest, FL 392, for possessions of Humbertus de Sabaudia (but only for the seigneurie of Cudrefin ?), compiled by Petrus Mareschet 1424-1428 and completed after his death by Guionetus de Tretorrens, remains largely unexplored, apart from a few reconnaissances that we copied for use in our research of the Gachet family. From the limited information we have from FL 392, we think some of the later tenants named in the marginal notations of FL 111 were among the reconnaissants enumerated in FL 392.

Quernets are summaries or digests of earlier reconnaissances. The information in FL 111 must have been copied or adapted from earlier sources, and that raises the possibility of errors in copying or even of reading personal names and local place names. Some of the unique names we encounter in FL 111 might well be scribal errors resulting from a misreading of the lost sources. It may be worth noting, also, that variants of personal names are often encountered at this period, so that Johannetus and Johannodus are used interchangeably, for example. Even when the script is particularly clear, it may not be possible reliably to distinguish between two people with similar names.

As for the sources used to compile FL 111, we have only the very limited internal evidence found in the text. There appear to have been at least two earlier terriers of indeterminate age, almost certainly during the long tenure (1311-1397) of the Grandissono family. Thus, on fol. 187, we find the names of a previous set of tenants, who in turn had been liable for the cense formerly recognized by the grandfather of the current tenant. Similar information is given for almost all of the tenants in this fragment. There are also several mentions of additional amounts owed to the church of Ressudens (the center of the parish that included Grandcour) involving property that belonged to the seigneurie, and there is one mention of a donation to that church in the indefinite past involving Dominus Jacobus de Grandissono, possibly a priest or even the curate of the parish, who, however, we have not been able to identify. The Archives de l'Etat de

Fribourg may have additional sources, such as AEF Grosses Estavayer 123b (about 1350) and 122 (1405), not yet examined.


