

## **ACV Fl 393 Cure de Bellerive, compiled by Anthonius Monachi, 1454-1458.**

« Recogniciones parrochialis ecclesie Beati Verani de Bellarippa Lausannensis diocesis recepte per me Anthonium Monachi notarium ad opus venerabilis viri domini Vuilliermi de Sarsens curati et rectoris eiusdem ecclesie. » The notary Monachi, however, signs himself Lemoyne, the French version of his surname. He is various cited in other records under either of these names. Some of the images are out of focus; new pictures are needed for fols. 133v-134.
