

ACV Fl 394 Cudrefin for Louis duc de Savoie, compiled by Bartholomeus de Tretorens from the protocols of his late father Guionetus de Tretorens, 1445-1458.

This volume covers the *châtelennie et mandement* of Cudrefin except for the « noble fiefs », which are covered in the next volume, Fl 395. The volume begins with an index that appears to date from the 18th Century, showing that the clerk had some difficulty with the ambiguous script of the 15th Century . The terrier has 597 numbered folios (plus introductory material), and the last reconnaissance is for the commune of Montmagnel.

However, the index does not correspond to the contents of this volume. A later notation at the beginning of the index says “Aven. N° 16 5.” However, the terrier for the district of Avenches that was once known as N° 16 is Fl 82, and it now appears that the index now found in Fl 394 is in fact a misplaced index for Fl 82. (See our analysis of Fl 82 for further details.)

Contents:

Introductory material : The present volume was compiled by Bartholomeus de Tretorens, based on the protocols of his late father Guionetus de Tretorens, for Louis, duke of Savoie. Bartholomeus was entrusted with these protocols at the request of Franciscus, count of Gruyère. He faithfully copied the reconnaissances from these protocols and added others that he personally recorded. His introduction is dated 10 feb 1457. Unless otherwise noted, the reconnaissances show the paraphe of Guionetus de Tretorens.
