

**ACV Fl 399 Cure de Bellerive 1486-1489 for Guilliermus Mayor  
canonicus Lausannensis curatusque ecclesiarum parrochialum  
Adventhice et Bellerippe, compiled by Bonafides Thovacii  
capellanus curatus Montigirodi (Diocese of Tarentaise).**

The previous terrier was compiled for the same Guilliermus Mayor by Petrus Garineti (ACV Fl 398, 1471) and before that, for a previous curate, Vuilliermus de Sarsens, by Anthonius Monachus (=Le Moine, Le Moyne, ACV Fl 393, 1454). The folio numbers in the volume are frequently illegible because they were cut during binding. The commissaire signs his name B<sup>des</sup> Thovacii.

157 Bartholomeus Bonivet de Bellarippa with approval of his father Johannes Bonivet, quod cum Francesia filia quondam Johannete Berthod uxor dicti Johannis Bonivet patris mis dicti confitentis \_\_\_\_\_ mea (presumably this should say that Francesia was the sister of Bartholomeus) in her testament (from her inheritance from her grandfather Johannes Berthod), and owed to the said Francesia by Jaquinodus Bidey (Bidel) de Murs en Vuilliez, this testament recorded 08 nov 1482 by Dompnus Johannis Bessardi, now the said Bartholomeus recognizes these obligations, 05 may 1487.
