Ramel (=Ramuz) et Vuilliermeta eius uxor, and 10 dec 1490 for the others.

4 Losineta (Lysoneta, Lisoneta!) uxor Vuilliermi Rissaud (Risaud. Risaulx) et Vuilliermeta uxor Petri Perrollet, et Vuilliermeta filia quondam Nyquilliz Guguit ? uxor Johannis Cuanier de Nant et Perrissona uxor Vuilliermi Cady de Gruen prope Muretum, with approval of censiars Jaquetus Perrollet de Lugnouroz, Vuilliermus Perrollet, Rodulphus Javet alias Bolioz (Bolliot), Glaudius Bonet (or Bovet?) whose wife is Johanneta, 10 dec 1490? (*datum die et anno quibus proxime supra in predicti recognitione*).

7v Nycodus de Vuilliod filius quondam Vuilliermi de Agnens de Lugnouroz, 04 dec 1490.

9 Vuilliermus de Chynaulx de Lugnouroz, property shared with Jaqueta filia Petri Boney ? uxor Aymonis Marilie nomine suo et Johannis eius fratris, 02 jan 1490 (style of the Annunciation ?).

10v Glaudius Tierri de Lugnouroz, ex acquisitione per me dictum Glaudium facta a Johanne Rod heredi quondam Johannis Ribbaux, 03 jan 1490.

12 Predictus Glaudius Tierri (Thierry) de Luginoroz tanquam devanterius Nycodi Vuilliod alias Agnes et Francesie filie quondam Johannis Nycod alias Gilliard uxoris Johannis Burroz (Buroz) de Mostier, 03 jan 1490.

14v Johannes Bovet (Bonet ?) de Geressyn, de bonis quondam eis Taborie, 03 jan 1490.

17 (In a different hand) Vuilliermus (dictus) Perrollet de Geressens, incomplete, lacks date and the expected statement that it was copied after the death of Johannes de Molendino by his son.
