A short terrier, in French, probably incomplete. On the cover and on the first page, designated **M**. There are two sets of page numbers, the first probably from the 17th Century, irregular, as if added by someone who was uncertain whether to number it as folios or pages. The second pagination, used here, was added much later (20th Century ?) in pencil. There are also some sections showing other foliations, suggesting that several reconnaissances originally with separate foliation have been bound together. There are marginal notations in several different hands, both in Latin and French, including a number of references to folio numbers in a terrier designated “Extentes per Vuilliermus Ruschat.”

At page 49, a small piece of paper is inserted, bearing on one side a sort of script sampler or alphabet prepared by someone from the 20th Century, and on the other side, apparently attached, an old label with later notations, discussed at the appropriate point below. Also on page 49 itself, at the bottom, an extensive doodle and grotesque apparently by Roulet Blanchebarbaz, with several Latin and German aphorisms. Other foliations are found at the beginning of some of the reconnaissances. The last reconnaissance in this volume, beginning at page 151, lacks the final page, which would have been p. 183, of which only a tiny fragment remains.

There are several mentions of earlier terriers, which may eventually lead to a better understanding of the purpose of the present volume.

(Pages 143-150 are blank, apart from an obscure notation at the top of p. 143 that might indicate the blank pages were reserved for a reconnaissance by Pierre de Treytorens.)
