36v Petrus filius quondam Johannis Perrini alias Ansoz de Constantina (title), or Petrus filius Johannes quondam Perrym alias Ansoz de Constantina (text), ex successione paterna de bonis quondam Marmete filie quondam Marmeti de Costel uxor is quondam Johannis Perrym de Constantina avi mis dicti confitentis, another group of properties de bonis et recognitione quondam Johannis Perrym avi mis dicti confitentis, 06 jun 1498. (The pedigree, not clearly stated here, is probably Petrus, the reconnaissant, son of the late Johannes, who was in turn the son of another Johannes (his grandfather), son of Perrinus, son of Ansermus. This Ansermus is the subject of various reconnaissances in earlier terriers, as are his son Perrinus and his grandson Johannes Perrin.).

39 Petrus Luppi alias Bescherraz de Mommagnyel, ex successione paterna, 06 jun 1498.

40v Jaqueta filia quondam ____ Luppi de Mommagnyel uxor Petri Verdom, et Petrus *Luppi* filius quondam Jaqueti Luppi dicti loci de Mommagnyel (title), but the text specifies the second party as Petrus filius quondam Jaqueti *Verdom* !, ex mea legitima successione paterna, and later in the text, dictus Petrus Verdom maritus dicti Jaqueta recognizes and approves these obligations, so the version stated in the title is incorrect, and that in the text apparently correct, 13 jun 1498.

Le prenommé Noble Godeffrey Griset bourgeois dudit Estavaie Conseigneur de Font de Cheres et de Marnant has received from Noble Hanß Rüdolff de Graffenried banderet et conseillier de Berne action et tiltre ayant de Noble Leon de Constantine Seigneur d'Orsens filz de feu Noble Pierre de Constantine, and the censes and rents for the fief of Charbuens, 27 florins, 14 oct 1545, witnesses Discret Jaques Demierre and others (not named), signature of Jean Marcuard, with small paraphe.
