

# **ACV Fm 1 quater Documents supporting rights of various ancestors of the Chalon family of Cugy**

*Abstracts prepared by John W. McCoy ([RealMac@aol.com](mailto:RealMac@aol.com)) © 2020.*

This volume is labeled A on the cover. It is referred to as “**Liber A**” in at least two other terriers for Blaise Chalon and his ancestors, Fm 3 bis and Fm 3 quater. The individual transactions appear to be mostly in the hands of the notaries whose signatures and paraphes appear at the end of each one. Many of the items bear marginal notations by Blaise Chalon, and some have been lined out, either because the instrument had been superseded by a later reconnaissance or other transaction (as noted in the margins), or, apparently, because the instrument was irrelevant but happened to be written on the back of some other significant transaction that was bound into this volume.

Many notaries are represented in this volume, and it is possible that some of their registers might survive in the Archives d’Etat de Fribourg, as the possessions and interests of the Mayor and Chalon families extended beyond the boundaries of the modern canton of Vaud.

After the répertoire, the contents are on a different paper and in different hands.

1 (While this folio is clearly labeled, the first paragraph is the end of some other transaction, demonstrating that the volume was assembled directly from separate copies of various documents prepared by the notaries who had recorded them, or by their clerks : ... sub pena dupli cum omni jure etc. secundum dictas consuetudines... datum ut supra, with small [ :- ] and larger [flourish at the end of a horizontal line forming a small heart, no dots or other decorations] paraphes, laudata est, but without a signature or the name of the notary.)

Prenominatus Johannes Lambelliez, datum ut supra :—, reconnaissance (but for whom, is not stated) for a parcel of land previously recognized by Johannodus Groumond, laudata est, with simple paraphe as described above, but without a signature or the name of the notary. (Margin : Tenet Johannes Borgonyon.)

1v Jaquetus Neret alias Leguens filius quondam Petri Neret alias Leguens de Vissin, datum ut supra :—, reconnaissance (but for whom, is not stated) for properties previously recognized by Perrodus Neret, laudata est, with same markings as the previous item. (Margin : Recognitum est jam.)

2v Humbertus Philymont nunc residens Cugiaci tanquam ususfructarius in bonis quondam Yssabelle ? (written *yſſ*) quondam uxoris sue filieque quondam Jaqueto Collom, reconnaissance for predictus Petrus Mayor, des bonis alias recognitis per dictum quondam Jaquetum Collom, text ends at the bottom of the page, incomplete – this text is included apparently because it was on the verso of the folio containing the end of the previous item. (However, marginal notation at the top : *Vide post folio xxiiii.* – but we have so far not discovered any related transactions “after” folio 24.)

3 (In a different hand, presumably that of Jaquetus Mayor, who signs this item) Jacobus filius quondam Jaqueti Blam de Fetignyer, 28 apr 1466, reconnaissance for Anthonia filia quondam Petri Mayor antenati de Cugie clericu uxorque Petri Saucteir clericu, ex accensione nova, de bonis alias recognitis per quondam Jaquetum Philimont, with signature and paraphe of Jaquetus ? (or perhaps Jacobus) Mayor.

4 Nicodus Jenod ? filius quondam Johannis Jenod burgensis Paterniaci, 11 may 1477, reprehendit, placitat, et recognoscit … de morte et obitu quondam Petri Mayor antenati de Cugie clericu, ab Oddeto de Rippa, Johanne de Treval burgensis Paternaci, et ab Anthonia filia predicti quondam Petri Mayor clericu et heredis (should be herede, referring to Anthonia, meaning she is the heir of Petrus Mayor – see next item) uxoreque Petri Saucteir clericu, with signature and paraphe of Johannes Leveti.

4v Oliverius Ruerat de Corcellis burgensis Paternaci filiusque quondam Jaqueti Ruerat, 30 may 1477, reprehendit, placitat, et recognoscit de morte et obitu quondam Petri Mayor antenati de Cugie clericu… ab Oddeto de Rippa burgensis Paternaci necnon a Johanne de Treval et ab Anthonia filia et herede dicti quondam Petri Mayor uxoreque Petri Saucteir, with signature and paraphe of Johannes Leveti.

6 Petrus filius quondam Roleti Cicudex alias Dusson (elsewhere Dosson) nunc morans apud Fetignyer, 03 feb 1490 Style of the Annunciation, reconanissance for Anthonia filia quondam Petri Mayor antenati, text ends with small paraphe (of the copyist ?) :—, but with an N at the end of the horizontal line. Beneath the text, the signature and paraphe of Franciscus Ruerat.

(Fols. 7-9 are blank.)

9v (Lined out) Anthonius Pignerat ?, apparently an acknowledgement of a debt to Petrus Saucterii, die Sabati festi Conceptionis Beate Marie Virginis 1481, much of this short item is illegible.

(Lined out) ~~Girarda filia quondam Nicodi Bersier de Cugie, debt to Petrus Saucterii clericus Cugiaci, 32 sols, die Lune ante Dominicam de Remiscere, 1483.~~

10 (All items on this jumbled page apparently lined out) Anthonius Pigneret residens Cugiaci pro se etc. debere confitetur Petro Saucterii clero, 12 sols, apparently a simple debt, die Veneris 05 mar 1481, signature and paraphe of Georgius ? Leveti lined out. Followed by very rough "Items" that all seem to be debts, possibly involving the same Anthonius Pigneret, various liturgical dates but no years stated. It is possible that this page was not relevant, and that it was the content on the other side, 10v, that was of interest at the time this volume was assembled.

10v (Lined out) ~~Johannes filius quondam Johannis Pictet alias Perrod de Menieres, 12 mar 1480 ?, debt to Petrus Saucterii, 14 sols, with signature and paraphe of Georgius Leveti.~~

(Lined out) ~~Girardus filius quondam Petri Mondo de Menieres, die et anno quibus supra (=12 mar 1480 ?), debt to predictus Petrus Saucterii, 18 (sols ?) erga computi inter ipsos facti..., with signature and paraphe of Georgius Leveti.~~ At the end of the text, small paraphe ∴ — .

11 Petrus Doucroux ? (very uncertain) aliter Jaquier de Montet, die Jovis ante festum Beatorum Apostolorum Symonis et Jude 1429, reconnaissance for Nicolleta filia quondam Johannis Mongner de Frasses nunc uxor Johannis Mochoz de Paterniaco ? ... ac nomine Ysabelle filie dicte quondam Johannis Mongner nunc uxor Petri Maior (=Mayor) de Cugie, with signature and paraphe of Petrus Uldriard.

Reynaudus Pillet de Montet, 13 nov 1432, reconnaissance for Nicolleta filia quondam Johannis Mongni ? de Frasses nunc uxor Johannis Mochoz de Paterniaco, ac nomine Ysabelle filie dicti quondam Johannis Mongni ? nunc uxor Petri Mayor clericus de Cugie, with signature and paraphe of Johannes de Treaul.

11v Petrus Bonins ? alias Chivilliar, Henricus frater eius, 12 dec 1432, reconnaissance for Nycholeta filia quondam Johannis de la Bretonere nunc uxor Johannis Mocho junioris, nomine suo et Ysabelle sororis sue filie dicti quondam Johannis uxor Petri Maior (=Mayor), with signature and paraphe of Johannes Crostel.

12 Germanus Verex Dieux ? carpentator morans apud Montet, 01 jan 1432, reconnaissance for predicta Nycoleta, with signature and paraphe of Johannes Crostel.

12v Nycodus Borcard de Montet, 17 jan 1432, reconnaissance for Nycoleta filia quondam Johannis de la Brethonery nunc uxor Johannis Mochoz filii quondam Francisci Mochoz burgensis Paterniaci, nomine suo et Ysabelle sororis sue filie quondam dicti Johannis de la Brethonery uxor Petri Maior (=Mayor) clericus de Cugie, signature and paraphe of unknown notary, possibly Marechet.

13 Prefatus Nycodus [Borcard], datum ut supra (=17 jan 1432), lease for the term of 4 years from the present date, from Nycoleta nomine quo supra, with the same unknown signature and paraphe.

13v (Entirely different hand from that found on the other side of this folio) Petrus Jaquier de Frasses, die Jovis ante festum Beati Petri in Cathedra 1432, reconnaissance for Nycolleta filia quondam Johannis de Bretoneira nunc uxor Johannis Mochoz de Paterniaco, nomine suo et nomine Ysabelle sororis sue filie dicti quondam Johannis uxor Petri Mayor clericu de Cugie, with signature and paraphe of Jaquetus ? Requimadens (his preferred spelling is uncertain, as the second syllable is abbreviated, and the abbreviation mark over the q is often ambiguous).

14 Johannes Meffre de Frasses, datum ut supra (=die Jovis ante festum Beati Petri in Cathedra 1432), reconnaissance for prefata Nycolleta nomine quo supra, with signature and paraphe of Jaquetus ? Requimadens.

14v Aymo Clerc (=Clerc) alias Quarembaux (elsewhere Carimbaux or similar) de Frasses, datum ut supra (=die Jovis ante festum Beati Petri in Cathedra 1432), reconnaissance for predicte Nicoleta et Ysabella, with signature and paraphe of Jaquetus ? Requimadens.

15 Jaquetus Roschati alias Ambrunnelaz (elsewhere Lambrunellaz or similar) de Cugie filius quondam Johannis Roschati alias Ambrunnelaz dicti loci Cugie, 20 jul 1456, possibly a lease ? or a transfer of properties ? (refers to documents of previous sales ?) from Petrus Mayor clericus Cugiaci, script is extremely vague, with signature and paraphe of Johannes Leveti.

15v Girarda relicta quondam Mermeti Mande[r] filia quondam Perrodi Licions ? de Cugie, 07 may 1456, donation upon her death to Anthonia filia Petri Mayor clericu Cugiaci, pro multis gratis serviciis, with signature and paraphe of Nycodus ? Girod.

16 Petrus Brugnet de Montet, 26 jul 1433, reconnaissance for Nycoleta and Ysabella daughters of Johannes de laz Brettunerie, with signature and paraphe of Jaquetus ? Requemadens. (Margin : Vide alia recognitione post folio xxv.)

16v Jaquetus Pillet de Montet, 26 jul 1433 (datum ut supra et anno quo supra) reconnaissance for Nycoleta et Ysabella, with signature and paraphe of Jaquetus ? Requemadens.

17 Petrus Pillet de Montet, beginning of a reconnaissance for Nicoleta and Ysabella, incomplete, no signature or date.

Petrus filius quondam Perrodi Pillet de Montet, die Jovis ante Dominicam de ? Carnispreviorum reconnaissance for Nicolleta relicta quondam Johannis Mochoz and for Yssabella uxor Petri Mayor antenati clericu Cugiaci, daughters of Johannis Mouner de Frasses, with signature and paraphe of Johannes de Vallangeno.

Johannodus filius quondam Girardi dou Fort alias Perrier de Vissin, 31 mar 1443, reconnaissance for Petrus Mayor antenatus de Cugie clericus, with signature and paraphe of Jaquetus ? Anthonie.

18 Amedeus Reis filius quondam Humberti Reis de Chavanes, die Jovis post festum Beati Bartholomei Apostoli 1444, reconnaissance for Petrus Mayor antenatus clericus Cugiaci nutritus quondam Domini Nicodi Mayor, not signed, but with notation at the bottom, per Petrum Mayor juniores.

18v The first item on this page is apparently the end of another transaction, evidently a reconnaissance for Petrus Mayor antenatus, die Jovis festi Ascensione Domini 1445 ?, with signature and paraphe of Petrus Mayor, with additional notation, per Petrum Mayor juniores.

Liona filia quondam Girardi Gautel de Vissens relictaque quondam Jaqueti Lambellier dicti loci, 01 may 1446, debt ? for Petrus Mayor antenatus, with signature and paraphe of Petrus Mayor [junior].

19 Aymo Cler alias Carambaulx de Frasses, 20 jun 1445, debt ? to Petrus Mayor, with signature and paraphe of Jaquetus ? Borgon[yon].

19v Johannes filius quondam Nycodi Cler alias Carnibaul ? (very uncertain) de Frasses, reconnaissance for Petrus Mayor antenatus clericus Cugiaci, apparently complete but lacking the date (datum \_\_\_\_\_) and with no signature or paraphe.

20 (In the same hand as the previous item) Johannes Clert alias Carembaux filius quondam Nicodi Clert alias Carembaux de Frasses prope Staviacum, 01 feb 1446, sale to Nycoleta relicita quondam Johannis Moschoz et Yssabella uxor Petri Mayor de Cugiac antenati clerici filie quondam Johannis de la Brethoners, no signature or paraphe.

(Fol. 20v is blank.)

21 Johannes Clert alias Carembaux filius quondam Nocidi Carembaux de Frasses, 01 feb 1446, sale to Petrus Mayor clericus antenatus de Cugie et Johannes Moschoz clericus Paterniaci (this Johannes is very much alive, according to this transaction – perhaps he was the son of Nicolleta and the elder Johannes Mochoz ?), with signature and paraphe of Jaquetus ? Borgnonyon.

21v Agnelleta relicita quondam Girardi dou For alias Perryer de Vissens, die Dominica de Letare 1446, debt to Petrus Mayor antenatus clericus Cugiaci, not signed, but there is a small paraphe ::— at the end of the text.

22 Agnelleta relicita quondam Girardi dou Fort alias Perryer et Johannodus eius filius de Vissins, 18 jun 1448, debt ? to Petrus Mayor antenatus, no signature or paraphe, but with notation at the end, per Petrum Mayor juniores.

22v Johannes filius quondam Girardi dou Fort alias Perryer de Vissins, 29 jun 1449, debt ? to Petrus Mayor, similar to above item, with signature and paraphe of Petrus Mayor [junior].

(Fol. 23 is blank.)

23v First item appears to be a judgement ? (unjunctum est ?) requiring payment ? of a debt ? to Petrus Sauteir, 03 feb 1470, with signature and paraphe of Franciscus de Prato. The second item is very similar, datum ut supra, with the same signature.

24 Item, remanxit (=remansit) debens relictta Johannis Lebet de Montet prefato Petro Mayor iii solidos causam licteram habita.

Petrus Cicudez antenatus et Petrus Cicudez junior de Sassel fratres et filii quondam Johannis Cicudex alias Dusson (elsewhere Dosson), 02 nov 1455, debt to Petrus Mayor clericus Cugiaci nomine rehempcionis certarum liberarum per ipsos fratres a dicto Petro clericico habitarum etc. solvendoos inter ipsos... , with signature and paraphe of Nycodus ? Girod.

Item, les Ginilliet alias Grialle ? de Montet solvunt ? semper michi Petro Chalon anno quolibet videlicet novent carrones ? ... bladi masure Staviaci ... ?

24v Petrus ? Anthonius ? Jinilliet ? de Montet, with approval of Nycolleta relictta quondam Johannis Moschoz de Paterniaco filieque quondam Johannis de laz Bretoneiryt ? de Frasses, 29 jun 1454, reconnaissance for Ysabella filia dicti quondam Johannis uxor Petri Mayor clericci Cugiaci, with signature and paraphe of Johannes Leveti.

Vuillermus Juliannilliet ? filius Anthonii Joliannilliet ?, mostly illegible, badly faded.

25 Nicodus Brunet alias Chaney de Montet with approval of the said Nycoletta, 29 jun 1454 ? (datum ut supra), reconnaissance for Ysabella etc., with signature and paraphe of Johannes Leveti. (Below this item : vide supra alia recognicione fol. xvi.)

Johannes filius quondam Cuaneti Lambelliez de Vissin, 29 jun 1454, debt to Petrus Mayor, 60 sols to pay off the debt, with signature and paraphe of Johannes Leveti.

25v Guillermus Cornu nunc morans Cugiaci nomine Theobarde filie sue, lease for 6 years from Petrus Mayor clericus Cugiaci, but lacks date, no signature or paraphe.

26 Mermetus filius quondam Jaqueti de Forno de Vissin, 16 sep 1431, reconnaissance for Petrus Mayor clericus Cugiaci, no signature or paraphe.

26v Johannes Pictet alias Drunyens ? (very uncertain) nunc morans apud Cugie, debt to Petrus Mayor for purchase of a horse, 8 sols, lacks date, no signature or paraphe.

27 Mermetus filius quondam Jaqueti de Forno de Vissens, 04 nov 1431, reconnaissance for Petrus Mayor clericus Cugiaci, with signature and paraphe of Johannes de Treaul. (Margin : Est vendue ladicta cense à Jehan Leguens comme tuteur de Glaude Proma de Visin.)

27v Johannodus Groumont de Vissin, reconnaissance for Petrus Maior (=Mayor) clericus Cugiaci, 04 nov 1431, with signature and paraphe of Johannes de Treaul.

Perrodus Neret alias Leguens de Vissin, 04 nov 1431 (datum ut supra), reconnaissance for the same Petrus Mayor (modo et forma quibus supra), with signature and paraphe of Johannes de Trevaul.

28v Jaquetus Collom aliter Paulud de Vissens, reconnaissance for Petrus Mayor clericus de Cugie, incomplete, properties not listed, no date, no signature or paraphe, remainder of this page and all of the next left blank.

(Fol. 29 is blank.)

29v Lyona filia quondam Girardi Gautel de Vissens nunc uxor Jaqueti filii quondam Johannodi Lambellier dicti loci de Vissens, reconnaissance for Petrus Mayor clericus Cugie, incomplete, no more information.

S'est vendu ad cense à Jehan Leguens comme tuteur Glaude Proma tenementier de ladicte piece.

Lyona filia quondam Girardi Gautel de Vissens nunc uxor Jaqueti Lambellier dicti loci de Vissens de voluntate et auctoritate presens Jaqueti mariti sui, 18 nov 1431, reconnaissance for Petrus Mayor clericus Cugaci, the text ending with a small paraphe :—, with signature and paraphe (but in a different ink) of Johannes Trevaul.

30 Nycoleta relicta quondam Johannis Mochoz de Paterniaco et Ysabella uxor Petri Mayor clericci Cugie sorores filieque quondam Johannis de la Brethonerit alias Monney de Frasses, 02 dec 1456, partage, with signature and paraphe (but in a different ink) of Petrus Lombardi.  
Additional subscription : Sic per voluntatem predicte Nycolete tantum quo ad partagium medietate Nycolete, datum quo ad precictam Ysabellam de auctoritate eius Petri viri sui 02 jun 1460, with signature and paraphe of Petrus Lombardi. Additional notation : Le present partage appartient à moy Blaise Chalon par mon partage d'avec mes freres et comme enfans et heritiers de Margarite fillie de feu Pierre Saucteir et d'Anthoine filie dudit Pierre Mayor, et aussi comme tiltre ayant de ladite Margarite sa seur de ladite Ysabel.

32 Cuanetus filius quondam Johannodi Lanbellier (elsewhere Lambellier) de Vissens, 25 nov 1431, reconnaissance for Petrus Maior (=Mayor) clericus Cugiaci, with signature and paraphe of Johannes de Trevaul.

32v Petrus filius quondam Girardi Michier aliter Prillat ? de Vissens, 13 may ? (either maii with an extra minim, or marcii lacking the c !) 1431, reconnaissance for Petrus Mayor clericus Cugiaci, with signature and paraphe of P ? Quin ? (very uncertain). (At the top, additional notation : Lesdites censes ont estés vendus à Jehan Leguens comme tuteur de Glaude Proma tenementier desdites pieces.) (Additional notation at the end clarifying the amount of the cense.)

33v Jaquetus Collom aliter Paulud de Vissens, reconnaissance for Petrus Mayor clericus Cugiaci, text ends with partial description of one property, no more text, incomplete, no date or signature, and the remainder of fol. 33v left blank.

34 Jaquetus Collom aliter Paulud et Petrus filius quondam Girardi Michier alias Prillat (fairly clear), 10 feb 1431, reconnaissance for Petrus Mayor clericus Cugiaci, with signature and paraphe of Johannes de Treaul.

34v Jaquetus Collom aliter Paulus de Vissens, 23 mar 1431, reconnaissance for Petrus Mayor clericus Cugiaci, with signature and paraphe of Johannes Gumenci.

35v Several notes regarding payments, the first dated die martis festi Beati Vacencii ? (presumably St. Vincent ?) 1431 for payemnt of 8 livres involved in the preceding items and concerning Petrus Maior (=Mayor), Jaquetus Collom, and Petrus Michier ; the second undated and of uncertain significance ; the third dated die Sanctorum Innocencium 1495, Ego Petrus Chalon clericus affirmavi Petrum Carlim, apparently receipt for payment of rents due.

36 Providi viri Jaquetus Bonet burgensis Paterniaci et Petrus Mayor de Cugie clericus, 26 oct 1464, agreement, first, that the said Petrus Mayor leases for 9 years various properties from the said Jaquetus Bonet, and further, the said Jaquetus likewise leases from Petrus Mayor, with signature and paraphe of Petrus Moroni.

36v Humbertus Philimont morans Cugiaci, 08 jan 1464, debt to Petrus Mayor, with signature and paraphe of Johannes Leveti.

Johannes Lambellier de Vissin, 08 jan 1464 (datum die et anno quibus supra), debt to Petrus Mayor, with signature and paraphe of Johannes Leveti.

37 (Most of the lower right quadrant of this folio has been lost.) Johannes Redes alias Quavuns ? de Staviaco, die Jovis post festum Beati Johannis Baptiste 1436, reconnaissance, the other party not named ?, no signature or paraphe, very likely this is only a very brief abstract.

Memento, various dates mentioned, at least one in 1440, but the text is highly abbreviated and poorly legible, with some losses in the last several lines.

Fiat clama et . . . , text uncertain, and about half of it lost.

(Fol. 37v is blank.)

38 Johannes Redet de Staviaco Lacus, 20 may 1434 (m<sup>o</sup> quatercentesimo tricesimo ~~tercio~~ quarto), long and detailed reconnaissance or accensation for Nicoleta uxor Johannis Moschoz junioris burgensis Paternaci and Ysabella uxor Petri Mayor de Cugie clericci, daughters of the late Johannes de la Brethonery alias Monngner (written Mōngner) de Montet, no signature or paraphe. However, at the bottom of fol. 38, there is a notation that may explain something of its provenance : Huiusmodi accensatio fuit quictata et abandonata per dictum accensatarium dicti accensatricibus ut continetur lictera contenta in quodam parvo libro a dorso signato isto et tali signo A. It is possible that the original document of 20 may 1434 was in the hand of Johannes Redet, as the text is in the first person, and no witnesses are mentioned.
