

ACV Fm 51 Payerne for Noble Girard Mistral.

The date on the cover (later annotation) is 1437; the ACV lists the date as 1436/1537. The volume contains acts recorded by many notaries dating from as early as 1437 and as late as 1537. Because of the great antiquity of many of the items, and the fact that they sometimes mention relationships, it may be useful to copy the entire volume.

The reconnaissances show allegiance to Jaqua filia nobilis viri Girardi Mistralis domini Combremondi Magni et quondam nobiliis Marie eius uxoris filieque quondam nobilis Johannis Demont domicelli Paterniaci uxoreque vero nobilis Petermand de Foucigny domini de Licet absentis, or to various predecessors. (There is some confusion in the specifications, which differ depending on the date of the reconnaissance. As best we can determine, the elder Johannes de Mont left a widow Ponceta and the younger Johannes de Mont, his son, was apparently married to Claudia de Siviriez, whose daughter was Maria de Mont, wife of Petermand de Foucigny. Ponceta had owned property in her own right, and her rents as well as those of her husband were thus inherited by Johannes de Mont the younger, and then by his daughter Maria, and then to Girard Mestral, and to his daughter Jaqua, wife of Petermand de Foucigny.)

The name Juenet could also be read as Ivenet, the latter spelling was used by the copyist who produced the registers of ACV Aa 12. There are many marginal notations, but for the most part they are very small and cryptic, perhaps to be deciphered at a later date.
