

## **ACV Fn 307 Hospitale Pauperum Beate Marie Virginis de Melduno, first volume of rights, 1280-1438**

The repertorium includes entries for this volume, fols. 1-302v, followed by entries for its continuation, the second volume, Fn 308, which contains fols. 303-643v. Many, but not all of the documents summarized in this volume exist in the Archives Communales de Moudon (cited below as **AC Moudon**), which also has other documents pertaining to the hospital that seem not to be found in ACV 307-310.

The entire series of volumes, Fn 307-310, needs to be analyzed in detail. The information presented here is a digest of the repertorium (part of which was reconstructed by the ACV), and transcripts and paraphrases of selected items. A rough count shows at least 1,005 items were copied or extracted into these four volumes, plus 3 items that are now incomplete due to lost pages. For the future, it would be useful to compare these volumes with the collection of documents in the inventory of the AC Moudon.

The extracts below are intended as a finding aid, and may be incomplete in various respects. The script is not always as legible or as well organized as we might wish, although these volumes are relatively clear by 15<sup>th</sup> Century standards. Errors in our transcripts are possible, and a number of obvious errors in the text of these volumes (errors of the copyist) were also discovered. In some cases, the latter errors could be corrected based on additional clues found within these volumes, or from the descriptions of the original documents that still exist in the AC Moudon.

A great number of these items concern “sales” (vendiciones), but at that period, a “sale” is more likely to be what we would consider today a “secured loan”: The “seller” offers an annual cense, in effect a payment of interest, in return for a loan from the “buyer”, generally with the provision that the “seller” can buy back (and thus extinguish) the obligation to pay the annual cense, by paying the “buyer” the original amount of the loan (this is the right of “reempcio” of “rehempcio”, and later, in French, “réachat”). Sale of existing loans occurred as well. The hospital, like most other “charitable” institutions and a number of families having the means to do so, functioned as a banker, lending money to individuals and other institutions, and treating the annual interest payments as its working income. These loans were secured against specific properties held by the “sellers” (i.e., the borrowers), or by pledging all of their assets, or by naming one or more individuals who promised to act as securities and who were therefore liable in the event that payments were not made as required in the contract.

Notices that are today usually known as “clausules de testament” are also numerous. When an individual recorded a testament, the notary would also prepare a separate notice, whose date was apparently that of the testament itself, and in the name of the testator (i.e., expressed in the first person), to be sent to each institution that was named as a beneficiary in the testament. In a few cases, the testament itself has also been preserved separately. While this seems to be the only logical way to explain the documents that now exist, the assumption that the date of the

“clausule” must be the date of the testament itself might be questioned. The fact that almost all of these notices start with “Ego, (name of the testator), in my testament...” strongly suggests at least that the testator was still alive when the “clausules” were prepared.

(Fols. 2-2v are lost. From the text at the bottom of fol. 1v, the “act de fondation” should have ended after only a few additional lines at the top of fol. 2. From the marginal sequence numbers, it appears items † iii and most of † iv have been lost.)

4v Donation par Louis de Savoie baron de Vaud en faveur de Perrod de Châtel fils de feu Jordan Provenczal des biens provenant de feu Jean de Popia bourgeois de Moudon (and then from his late son Joffredus de Popia – and these “biens” had been declared “commissas et eschetas pluribus et diversis causis”, implying either unpaid debts, an absence of heirs, or some other circumstance that would occasion the confiscation of *these* properties from Joffredus de Popia or from his estate ; note that Agneleta de Gillarens, widow of Joffredus de Popia, next married Perrodus de Chastel, the recipient in this donation, and there seems to be no indication that she had children by either of her husbands), et de huiusmodi nos requisierint et nobis humilliter supplicaverint **Nobiles viri Dominus Anthonius de Vuilliens miles et Anthonius Cornuti de Vuilliens domicellus... , datum vicesima die mensis Januarii apud Rotundomontem anno domini millesimo quatercentesimo tercentesimo septimo**, no notary, witnesses, or other functionaries named. (Margin : ‡ vii) (This is one of the very few records that have come to our attention where the two Anthonii de Vuilliens appear together ! Unfortunately, the document does not seem to exist either in the ACV or in the AC Moudon. Further, no other persons or facts are mentioned that would help to clarify the date. There are several possible interpretations : If *quatercentesimo* is redundant and should have been lined out, the year becomes 1307, within the reign of Louis II de Savoie, but possibly not within the dates of the other persons named. If *quatercentesimo tercentesimo* is an extremely careless error for *tercentesimo tricesimo*, the year becomes 1337, entirely plausible. If *quatercentesimo tercentesimo* should have been *tercentesimo quadragesimo*, the year becomes 1347, but we have come to believe that Anthonius de Vuilliens the elder had already died by 1342, see below, fol. 186. Joffredus de Popia seems still to have been alive in 1335, see below, fol. 74, and dead by 1339, fol. 221, so the correct date would seem to be after 1335. It is also possible that the date is written incorrectly (as shown in Fn 307) in the original, in which case the document could easily be hiding in the inventories of either archive without a date and possibly also without a description.)

5 Donation par Amédée de Savoie en faveur de l'hôpital de Moudon d'une cense annuelle de 60 livres, approving donation by the late Petrus de Castello, 05 dec 1363. (ACV reconstructed repertorium says in error that the donor was Louis de Savoie, but he died in 1349 !) (Margin : ‡ viii)

6v      Reconnaissance en faveur de Amédée de Savoie par le recteur de l'hôpital de Moudon  
**Vuillermus dictus Magdellen**, 12 dec 1343 (indiction 1). (There is no sequence number in the margin. This item may have been considered part of, or an attachment to, the preceding item. However, see below, fol. 46 (A xxx), where another copy of apparently the same instrument is found, but there dated 13 dec 1367, thus apparently (but not quite) resolving a number of discrepancies relating to the present item.)

The items eumerated on fol. 6v are :

Unam domum sitam ante dictum hospitalis juxta aquam Merone et domum Roleti Bestiant quondam a parte Broye, cense 6 deniers (“pro census” ; all the censes are so labeled on fol. 6v, the word redditus is not used).

Ex legato facto dicto hospitali per Roletum de Sancto Mario et Perrissonam eius uxorem, unam domum juxta domum que quondam fuit Martini de Raisia [ex una parte,] et domum Mermeti Borgonion ex altera, cense 6 deniers.

Ex legato per Girardum nepotem Rodulphis de Fruencia ?, quondam domum situm in carreria Bastie a parte boree, juxta domum Boverii Milliet a parte anteriori, et aquam Broye, cense 8 deniers.

Ex legato sibi facto per Brisetam Pichoda et eius filium, subtus Burgum, unam ochiam juxta ochiam heredum Jaqueti Pictet et cultile Nicoleti de Vuillienjauz, cense 2 deniers obole.

Ex legato per Nicolaum de Grueria quondam, circa quatuor falcatas prati sitas eis Mares (no more text on fol. 6v.)

(There is a folio bound between fols. 6v and 16 at this point, originally unnumbered, now numbered in modern pencil VII, which was evidently believed to be the continuation of fol. 6v during the restoration of this volume in 1937. This folio is blank on the verso. At the bottom of this folio is a notation in pencil, that fols. 7-10v were noted as missing as of 1937, and fol. 11-15v were blank and were suppressed during restoration of the volume at that time. However, we think this folio VII was not originally placed here, as it ends “Actum apud Meldunum inter domum Amedei de Vuilliens quondam presentibus Francisco de Lustita lombardo, et Stephano Faczon ? de Chambrier”, but without the rest of the usual closing formalities. As the only Amadeus de Vuilliens known to us died much later, his testament or notice of testament dated 02 oct 1360, this cannot be part of a reconnaissance from 1343. Other references to the rector Vuillermus Magdalen are known, all of them much later. Among other living persons mentioned in this fragment are Thomas de Glana (died after 1369), the rector Jaquetus de Capella (he held that position roughly 1350-1360), Jaquerius Ysabel, and his son Nicoletus. The item of which this is a fragment should therefore be from no earlier than 1360. The script and paper appear similar to that of Fn 307, although the script is less regular.)

The items enumerated on the folio labeled VII are :

... versus stagnum de Chavanes juxta (juxta is written out in full in most items on “folio VII”, but always abbreviated on fol. 6v) pratum Petri Girardi et pratum Johannis de Grueria ex altera, cense 16 deniers (“redditus”, a word not used on fol. 6v).

Medietatem prati de la Giry ? pro indiviso cum Thoma de Glana subtus pratum Andree Estoper, 3 deniers “redditus”.

Ex empto a dictis Rilet ? de Ermenges, unum pratum situm subtus Ermenges in loco dicto ouz Chanoz juxta pratum Cristinodi de Beuroz (the first letter of this name possibly, altered, and other records suggest it should be Revroz or similar) et pratum Stephani Gunsa ? (Comensa ? – uncertain abbreviation), 6 deniers cense.

Unam domum que fuit quondam Aymonis de Albona sitam juxta **domum Jaqueti de Capella rectoris hospitalis** ex una parte, et domum Thome de Glana que fuit Rolete Valanczonaz ex altera, cense 4 deniers. (But on fol. 6v, the reconnaissance of which this “folio VII” is alleged to be a part identifies **Vuillermus dictus Magdalenn** as the current rector !)

(For what appears to be the actual source of the items on fol. 6v and 7, see below, fol. 46, where there is also continued discussion of the problem of the date.)

(The remainder of the original repertorium is intact and was used to establish the following outline of Fn 307-308, which was then supplemented with information from the text. However, it turns out there are significant errors and omissions in the repertorium. Significant errors have been found both in what remains of the original repertorium and in the text itself.)

16 Cecilliola relicta Cononis Agassy burgensis de Melduno, notice of testament, reconnaissance by her sons Dominus Vuillermus Agassy sacerdos and Roletus his brother, 19 jun 1347, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A i. The documents

held by the hospital in the 15<sup>th</sup> Century were organized into bundles or “fardelli”. The first bundle seems to have been reserved for documents from the sovereign or from the ecclesiastical authorities, marked †, described above in Fn 307, fols. 1-6v. The remainder of the documents were in bundles A-N, described in the rest of Fn 307 and continuing through Fn 308-310.)

16v Johannes Nefigniar de Melduno, reconnaissance for Dominus Girardus Fucherat presbiter de Melduno rector altaris Beati Andree constructi in capella Beate Marie Virginis de Melduno per Perrodum de Castello, 29 sep 1373, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A ii)

17 Roletus dictus Marchiant burgensis de Melduno et Jordana eius uxor, bequest, daughter Johanneta, various sources, universal heirs Perrisseta et Jacola sorores filie quondam Perreti dicti Marchiant fratri mei dicti Roleti, 23 feb 1348, recorded by Johannodus Arma de Melduno clericus and copied after his death by Anthonium Arma de Melduno diaconus, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A iii)

18v Girardus Roberti burgensis de Melduno et Jacoba eius uxor, sale to the hospital with approval of their son Stephanus, cense, 09 feb 1344, recorded by Johannodus Arma, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A iv)

19v Perrodus dictus Cheneveis ? sutor morans in Burgo Melduni, donation, pro remedio anime mee et Perrete uxoris mee, 09 dec 1351, recorded by Perrodus de Syens, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A v)

20 Perrodus dictus Libaux (but later called Perrodus Baux ; hence, this should probably be read as li Baux) de Melduno clericus, evidently a complete testament, many bequests, ochia en Bevouges, universal heir his sister Jacola wife of Aubertus dictus Cova (clear) burgensis de Melduno, mention his brother Mermetus, also Mermeta daughter of the said Aubertus Cova, wife of Stephanus Bollion, also Perrissona his illegitimate daughter by Marguerona dicta Mulgaz de Dinisiez, also Johannodus his illegitimate son, also niece Jacola daughter of his brother Mermetus, 03 jan 1346, recorded by Johannes Thorenchii de Melduno clericus, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A vi)

22v Jaqueta relicta Rodulphi filii quondam Humberti de Chavanes supra Meldunum, Johannodus, Perrodus, et Aubertus filii dicti Jaquete et quondam dicti Rodulphi, die Martis ante Assumptionem Beate Marie Virginis 1325, sale to Nicolaus filius Johannodi de Grueria burgensis Melduni, res et possessiones nostras infrascriptas sitas in villa, territorio, et finagio de Chavanes, in effect a secured loan of 40 livres, annual cense to be paid by the vendors is 2 modii bladi (1 medii frumenti, 1 avene) with other conditions, assigned on their properties,

26 Thomas filius quondam Cristini de Popya burgensis de Melduno et Alexia eius uxor, sale of cense to Johannes dictus Sarally filius quondam Uldrici de Prez domicelli, ochiam en Bevouges, datum in vigilia Assumptionis Beate Marie Virginis 1315, recorded by Stephanus de Burgo clericus, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A x)

27 Johannis dictus Sarry filius quondam Uldrici de Prez domicelli, quod cum Thomas filius quondam Cristini de Popia burgensis de Melduno et Alexia eius uxor michi vendiderint (see the preceding item), bequest to the hospital, 06 sep 1345, recorded by Johannodus Arma clericus de Melduno, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A xi)

28 Johannes alumpnus Bisonii du Chaffa burgensis de Melduno, reconnaissance, ochiam, en Bevouges, 25 mar 1356, recorded by Perrodus de Syens, copia, with signature and paraphe of Uldriodus Guilly. (Margin : A xii)

28v Johannodus filius Uldrioci Burricar de Siens morans Melduni, reconnaissance, domum en Laya de Melduno a parte Merone, 2 sols cense, et debeo solvere theysas domino, quam domum acquisivi de laude dicti Jaqueti [de Capella, rectoris hospitalis] a Magistro Johanne de Columbemanasterio crisivisserio ? de Melduno, 26 nov 1350, recorded by Perrodus de Syens, copia, with signature and paraphe of Uldriodus Guilly. 30 Vuilliermus dictus Bugnyet cappellanus filius quondam Stephani de Tyerrens burgensis Melduni, donation, domum in Burgo Melduni, several other properties, with approval of Marguereta alumpna quondam Domini Petri curati de Mustrouz (written Mustruz) neptis mee nunc uxoris Jaqueti Eschiffar, 30 jul 1362, recorded by Jaquetus de Tors clericus Lausanne, copied after his death at the request of Guido, bishop of Lausanne, by Mermetus de Escleppens clericus Lausanne, copia, with signature and paraphe of Uldriodus Guilly. (This item, identified in the margin as A xxx, is to be compared with the document copied on fol. 6v, above, with its appended folio, originally unnumbered but now identified with a modern pencil notation VII. The version on fol. 6v is dated 12 dec 1343, but that date contradicts information within the document itself. There are a number of other differences, and the part of the document identified as fol. VII may well be a later addition, replacing lost folios 7-10v. The version here on fol. 46 seems more likely to be correct, or likely to be *more correct*. The version of fol. 6v indicates the date fell in Indiction 1 (the “Indiction” is a repeating cycle of 15 years that began in the 4<sup>th</sup> Century, and was followed by the Vatican well into the 16<sup>th</sup> Century). 1343 should have been Indiction 11, while 1367 was correctly Indiction 5 ! If the induction is not also in error, we might suppose that the date should be in 1363 ! As a method of gaining further insight into the correct date of this reconnaissance, it may be possible to locate the bequests it mentions, somewhere else in Fn 307. Of those : The testament of Roletus de Sancto Mario, fol. 291v (C. xxi, dated 08 oct 1347) ; Bruseta dicta Pitita uxor Stephani Fornerat, fol. 37v (A xxv, dated 20 jul 1343) ; Girardus de Fruencia, Fn 308, fol. 349v (C. lxiii, datum in crastino festi Beati Petri in Cathedra 1348) ; the testament of Nicodus or Nicolaus de Grueria has

not yet been located. The 10 documents mentioning the rector Magdelena in the inventory of the AC Moudon are all dated in 1362-1363, with the exception of one dated in 1373 involving a reconnaissance by Olivier Morenchat, but the latter date could conceivably have been misread. We conclude that the most likely date for the present reconnaissance is **13 dec 1363**. The rector Magdelena succeeded Girardus Arma in 1362, and was succeeded in 1364 by Petrus de Tremelies, in turn succeeded about 1365 by Perrinus de Pontallia, who remained in this post until at least 1370.)

See above, fol. 4v, for the only known occasion where both Anthonius the elder and younger are mentioned in the same document, dated provisionally in 1337 after attempting to correct an obvious scribal error. However, see also above, fol. 133, where Anthonius the elder is definitely alive on 08 may 1343. The puzzle is compounded, apparently, by the observation that all of the other parties to whom censes were owed approved this transaction, except for any representative of the de Vuilliens family. Could the date be in error? We were unable to discover anyone apart from Anthonius de Vuilliens mentioned in this document whose status (living, dead, married, widowed, etc.) in 1342 would be illogical, but it remains possible that the text was still incomplete when the document was signed, and the details of some of the properties were filled in later, including the

anachronistic fact that Anthonius had died. With this latter possibility in mind, we give the complete transcript, noting some information that could have been added later to the lost original.)

In view of all the other contingencies that could have arisen for a “future sale”, was it ever appropriate for this parcel to be included here? Consequently, the seemingly anachronistic or at least problematic statement about cense owed to the heirs of Anthonius de Vuilliens, who by other records should still have been alive in 1342, could have arisen if all of the text concerning this property had been added to the original document at a later date, in the form of insertions or marginal notations, well after it was originally prepared and sealed, and if, when the document was copied into Fn 307, the position of the added text relative to the original text, as well as any editorial markings that may have been present, were not preserved in the copy.)*
