The repertorium for this volume is found in Fn 307. Fn 308 is the continuation of Fn 307. Fn 307 contains fols. 1-302v, and the second volume, Fn 308, begins with fol. 303. In the same way, Fn 309 and 310 continue the series, with the repertorium for these two volumes in Fn 309, and the foliation continuing from Fn 309 into Fn 310. This plan would be easy to navigate, except that the ACV supplied its own folio numbers for the continuation volumes Fn 308 and Fn 310. Because of the way the indexes are structured, and because of some internal references to folio numbers, we use the original foliation here. Many, but not all of the documents summarized in this volume exist in the Archives Communales de Moudon (cited as AC Moudon), which also has other documents pertaining to the hospital that seem not to be found in Fn 307-310.

The documents that were copied or extracted in Fn 307-310 were organized into bundles of “fardelli” of 100. Fn 307 contains the transcripts of bundles A, B, and part of C. Fn 308 continues with the remainder of bundle C, followed by D, E, and part of F.

The entire series of volumes, Fn 307-310, needs to be analyzed in detail. The information presented here is a digest of the repertorium, and transcripts and paraphrases of selected items.



303 (First folio of Fn 308.) Lined out continuation of document concerning Anthonius Brenles, the first page of which is in Fn 307 on fol. 302v, the last page of that volume, where it is also lined out. The lined out text continues in Fn 308 to the bottom of fol. 304, then the same document begins again at fol. 304v.

304v Anthonius Brenles clericus de Melduno, sale of cense to Perronetus de Laya burgensis de Melduno, rector of the hospital, assigned on his house in Rosto Borgello Melduni, 23 feb 1404, recorded by Uldriodus Ysabel, pro copia, with signature and paraphe of Uldriodus Guilly.

306 Johannes dominus de Monz miles ballivus Waudi, notum facimus universis presentibus et futuris, quod Humbertus filius quondam Domini Petri de Mollens presbiteri et Marguerona uxor eiusdem Humberti constituti personaliter coram mandato nostro, videlicet Stephano de Burgo

clerico de Melduno ad hoc specialiter constituto, sold to Nicolaus filius Johannodi de Grueria burgensis de Melduno, domum cum fundo eius sitam in Villa Nova de Melduno ante furnum inter domum muratam que fuit quondam dicti Domini Petri de Mollens ex una parte, et domum Tricilium ? (script very uncertain) relicte Thome Sutoris ex altera, for 9 livres, on which cense of 3 deniers is owed to the church of St. Stephen in Moudon, datum et actum Melduni in vigilia Beati Mathie Apostoli 1310, recorded by Stephanus de Burgo, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxix) (AC Moudon, M 58, 46, date 05 mar 1322.)

308 Perrisseta et Johannete sorores filie quondam Humberti dicti Bauz burgensis de Melduno, sale to Nycolaus filius Johannodi de Grueria burgensis de Melduno, unam posam terre sitam in territorio de Melduno versus lo Chaffa quondam Thorenchii de Grueria in loco dicto ou Pacot, cense of 3 deniers owed to the church, die Lune post Nativitatem Beati Johannis Baptiste 1329, recorded by Johannodus Palliere clericus notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxx)

309 Hugonetus dictus Contoz burgensis de Melduno, sale to Guichardus de Tyerens habitator Melduni et Johanneta uxor sua, unam ochiam sitam in Campo de Lespina in territorio Melduni inter ochiam Mermeti de Lucens ex una parte et campum Domini Anthonii de Vuilliens militis ex altera, facta sunt omnia predicta de laude **Jaquete relicte Johannis de Vuilliens domicelli**, in cuius rei ego dictus Hugonetus et ego dicta Jaqueta que predicta laudo..., die Lune post festum Beati Mathie Apostoli 1331, recorded by Perrodus Fornerat de Burgo clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxi)

310 Petrus de Gimel nepos Domini Petri de Communie canonici Montisjovis, reconnaissance, domum que fuit Jacobi Mayat sitam in villa Melduni prope domum dicti hospitalis, 20 may 1332, recorded by Stephanus de Burgo, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxii)

310 Girardus filius quondam Roberti de Burgo burgensis de Melduno, sale of property, de puro et libero allodio, to Dominus Anthonius de Vuilliens miles, Girardus de Vuilliens domicellus, et Johannes de Vercellis burgensis de Melduno, procuratores novi hospitalis pauperum Beati Marie de Melduno nomine et ad opus dicti hospitalis et pauperum eiusdem, cense owed by Stephanus dictus Renczat de Melduno nunc rector dicti hospitalis, pro domo sua quam a me tenebat, sita in Villa Nova de Melduno ante cimisterium Beati Stephani de Melduno, the sale approved by Jacola wife of the said Girardus filius Roberti venditor, 10 may 1333, recorded by Perrodus Arma clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxiii)

312 Cono dictus de Vuilliens auriga (=charioteer in classical Latin, i.e., a cart driver or perhaps a pilot) morans Melduni et Johanneta eius uxor, reconnaissance for Mermeta relicta Stephani Renczat de Melduno rector of the new hospital, for the grangia of the said hospital, that was from the late Stephanus Renczat, sitam in Villa Nova de Melduno ante ecclesiam Beati Stephani, 28 jul 1336, recorded by Johannodus Arma clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxiiii) (Evidently, Mermeta continued to manage the hospital for some time after the death of her husband, and the next rector, Roletus Paczot, married her has a condition of his employment.)

312v Viannona dicta Barbereta de Melduno, bequest, cense owed by Johannes dictus Maulpitet (written Maulpit₃) de Vuicens et Agneleta eius uxor, also owed by Richardus dictus Clemence de Santo Martino, and these approve the bequest, die Martis ante festum Purificationis Beate Marie Virginis 1342, recorded by Conodus Raficel, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxv)

314 Stephanus alumpnus Perrodi Bauz de Melduno clerici et Marmeta eius uxor, sale to Marmetus Grenon de Tyerens burgensis de Melduno et Allissona eius uxor, ochia, 12 deniers cense owed to Dominus Anthonius de Vuilliens miles a quo dicta ochia movere dignoscitur, 18 oct 1343, recorded by Perrodus Fornerat de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxvi)

315 Agnelleta filia Uldrici Trivel ? (or possibly Crivel ?) burgensis de Melduno, with approval of her husband Girardus filius quondam Stephani de Ranary ? de Fez, quictacio to the hospital (rector Perrinus de Pontallia), scilicet omne jus meum casalis siti ante ecclesiam Beati Stephani de Melduno inter cimisterium dicti hospitalis et domum Domini Nicolay de Pont ? presbiter, quod casale partitur cum Thoma de Glana burgensis de Melduno, 03 may 1347, recorded by Perrodus de Syens notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxvii)

315v Michael Porra sutor burgensis de Melduno with approval of his wife Perrisonna and of Jacobus Thoren burgensis de Melduno, sale to Stephanodus filius Luyseti dicti Synouz ? cossanderius de Melduno, ochiam, cense owed by Jacobus Thoren burgensis de Melduno, 23 mar 1350, recorded by Johannes Thorencii notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxviii)

317 Roletus filius quondam Jaqueti Piwit, reconnaissance, duas posas terre et prati sitas in territorio Melduni inter terram Perrodi de Frenay (=Fernay) et terram **herendum Domini Anthonii de Vuilliens militis antenati**, et affrontat terre Jacobi Thoren a parte ville Melduni, et prato Thome de Glana a parte de Lucens, subtus domum meam dicti Roleti et comparcionariorum meorum, 20 mar 1350, recorded by Perrodus de Syens notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xxxix) (This item presents a problem, in that the notice of testament of Anthonius de Vuilliens miles, who could be taken to be this one and not Anthonius the younger, is dated, according to several different records, in 1356, the same year his widow Elynoda is first mentioned. Is the date 20 mar 1350 correct ? The document copied here still exists, Archives Communales de Moudon, M 58, 385, "Rolet, ffeu Jaquet Pinvit, tient de Jaquet de Chapelle, recteur de l'hôpital de la Vierge-Marie, 2

poses de terre et pré rièvre Moudon, entre la terre de Perrod de Fernay et celle des hoirs de sire Antoine de Willyens, chevalier, l'aîné etc. sous la maison dudit Rolet, sous la cense de 2 coupes de messel", with the date 20 mar 1350. However, other references to Anthonius the elder having died before 1350 have been located in Fn 307.)

318 Petrus de Volens ? (apparently not Bolens ? – but elsewhere the name appears more likely to be Bolens) presbiter commorans Melduni procurator et procuratorio nomine tocius cleri de Melduno, with approval of Dominus Girardus Arma, Dominus Johannes Nicodi (Nicody), et Dominus Johannes Malliard (Malliar) presbiteri, accensation to Jaquetus de Capella, rector of the hospital, campum, 25 oct 1353, recorded by Perrodus de Combremont clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xl)

319 Geraldus de Perel ? de Dinisie morans Melduni, quod cum ego acquisierivi a Conone filio dicti Bel Emonet et Jaqueta eius uxore, quandam parvam domum suam seu cameram sitam ante hospitale, reconnaissance, 06 jan 1354, recorded by Girardus Choupart de Melduno, lacks subscription and signature of Uldriodus Guilly. (Margin : C. xli)

319v Stephanus Magnyn burgensis de Melduno, bequest, 27 jul 1348, recorded by Mermetus de Burgo clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlvi)

319v Johannes dictus Magnyn burgensis de Melduno, bequest, 10 aug 1348, recorded by Perrodus de Combremont clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlvi)

320 Jacobus Salamine filius quondam Johannis Salamine burgensis de Melduno, sale to Johannodus et Perrodus de Fruencia fratres burgenses de Melduno, 03 mar 1336, recorded by Jacobus Serraceni de Melduno clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlvi)

321v Girardus filius quondam Henrici Salamine burgensis de Melduno, sale to Johannodus et Perrodus fratres dicti de Fruencia burgenses de Melduno, quartam partem medietatis casalis quod fuit quondam Rodulphi Salamine quondam patrui mei, quod casale jacet in Villa Nova de Melduno inter domum Agnesole relicte Uldrioti de Chesales ex una parte, et domum seu grangiam eisu Bauz ex altera, et partitur ipsa quarta pars aliis tribus partibus dicti casalis quas dicti fratres acquirerunt perpetuo et Jaquinodo Salamine consanguineo meo... , die Lune post Exaltacionem Sancte Crucis 1337, recorded by Perrodus Fornerat de Burgo clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlvi)

322v Roletus dictus de Sancto Mario burgensis de Melduno, with approval of his wife Perrissona, bequest to the clergy of Moudon and the confratria of St. Nicolas, 08 oct 1347, recorded by Johannes Thorenchii de Melduno clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlvi)

323 Jaquetus de Capella rector seu gubernator hospitalis pauperum Beate Marie de Melduno, quod cum Mermetus filius quondam a la Rossa de Ponte de Melduno in suo testamento et sua

ultima voluntate dederit et legaverit to the church of St. Stephen, and other bequests, assigned on a cense owed by Roletus Arbelester quondam burgensis de Melduno filius quondam Rodulphi Arbelester burgensis de Melduno, and the property has been sold to Giroldus de Dinisiez and then purchased by the rector for the use of the hospital, 07 feb 1352, recorded by Johannes Thorenchii de Melduno notarius, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlvii)

325 Jaquetus de Capella, bequest to the clergy of Moudon, 07 sep 1360, recorded by Perrodus de Syens, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlviii)

325v Jacola relicta Jaqueti de Capella quondam rectoris hospitalis, with approval of Vuilliermus dictus Magdelena nunc rector dicti hospitalis et Thomas de Glana consiliarii eiusdem hospitalis, bequest to the clergy of Moudon, 26 sep 1363, recorded by Johannes de Vuallacrest clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. xlix)

327 Thomas de Glana et Johannes de Vercellis burgenses de Melduno et Girardus Arma de Melduno presbiter rector hospitalis, quod cum Nobilis vir Dominus Johannes condominus de Blonay miles vendiderit et debeat perpetuo nobis et rectoribus ac procuratori ville de Melduno qui nunc sunt vel qui pro tempore futuro fuerint cuilibet nostrum in totum et insolidum nomine et ad opus dicti hospitalis..., videlicet 30 livres on which cense is owed annually, securities Dominus Nicodus de Blonay his brother, Dominus Aymo dominus de Bossonens, et Dominus Johannes de Vuippens de Friburgo, milites, now we grant the said Johannes de Blonay and his securities the right to repay and redeem the said sum and cense within the next 3 years ?, but later in the text this term is stated as 5 years, 11 oct 1361, recorded by Perrodus de Syens notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. l)

329v Petrus Renczat, testament, universal heirs his sons Stephanus clericus and Vuilliermus, various bequests, daughter Maria, approval by his wife Perreta, datum in crastino Translacionis Beati Nicolay Episcopi 1313, recorded by Stephanus de Burgo, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. li)

331 Nicholetus dictus Chinet de Melduno et Jaqueta eius uxor, testament, mention Johanneta and Perrissona sisters of Nicholetus, and Johanneta sister of Jaqueta, 07 mar 1348, recorded by Perrodus de Combremont clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lii)

332 Vuilliermus dictus de Grueria burgensis de Melduno, bequest, executors Rodulphus de Glana his nephew, Dominus Thorenchius de Grueria his son, priest at the monastery of Alta Crista, Johannes de Yllens domicellus, and Johannes de Viviaco burgensis de Melduno, 09 oct 1348, recorded by Mermetus de Burgo clericus, and copied after his death by Johannes Roberti de Cussey clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. liii)

333 Perrissona filia quondam Berthodi Serraceni burgensis de Melduno, bequest, universal heir her brother Jacobus ("de Thoro" ?), executors Johannes Thoren de Melduno clericus consanguineus meus et Jacobus Thoren eius fratrem, witnesses Petrus Pitet, Roletus Comparrat,

et Stephanus filius Petri Orelly, 10 may 1349, recorded by Cono Raficel clericus, and copied after his death by Dominus Rodulphus de Cussey curatus de Altavilla, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. liii)

334 Girardus Molliar de Melduno, testament, various bequests, universal heir his daughter Perreneta (possibly altered to Perreta), mention his brother Johannes Molliar, ... Item, quictavi et quicto Perrodo filio Jacodi de Cabana Mistralis supra Meldunum de triginta novem solidis Lausannensibus quos ipse michi debet, scilicet quinque solidos Lausannenses. Mention his sister Stephaneta. He notes several debts owed to him by others, including Michael filius quondam Meynerii de Reyvro, 13 deniers, and Perrodus de Reyvro of Ermenges, 2 sols and 3 deniers, 19 apr 1349, and his brother Johannes approves 26 apr 1349, recorded by Perrodus de Syens notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lv) (AC Moudon, M 58, 320, date 19 and 26 apr 1349, "Testament entre particuliers. Girard Malliar, de Moudon institue héritière sa fille, Perrete, lui substituant, au cas de décès sans héritiers, son frère (à lui), Jean Malliar et ses successeurs, et à ceux-ci, l'hôpital de la Vierge-Marie de Moudon; Il lègue à d Jean de Germagny pour lui, testateur, sa femme, et sa mère, 3 sous et à chacun de ses 3 vicaires 6 deniers, à son clerc 3 deniers; A la confrérie du St-Esprit du Bourg pour lui, sa femme et sa mère, une coupe de froment en tout, outre le bichet qu'il doit comme confrère (pro confratrica mea); Item, il donne quittance à Perrod, fils du mestral Jacod, de Chavannes-sur-Moudon, de 5 sous sur 39 sous qu'il lui doit; Item, il donne à sa soeur Etiennette une chèvre que garde le Rosa de St-Cierges, et 22 deniers qu'elle lui doit; Item, il remet à Perrod, clerc de Boulens, tout ce qu'il lui doit excepté 5 sous qu'il paiera à ses héritiers; Il déclare que Uldric Picz, de Ropraz, lui doit 17 deniers, de même que Michel, ffeu Reynier de Reyvro, 13 deniers; Michel de Granges, d'Hermenches, 9 deniers; Perrod de Reyvro, d'Hermenches, 2 sous 3 deniers; Perrussod de la Croix de Moudon, 2 sous 2 deniers, sur lesquels il redoit au fils de celui-ci une journée (jornevam); de même Aubert Magnin lui doit 16 deniers et lui Girard garde une toge de drap blanc et une [] (mangram) de drap vert; Item, Mermet Juglarat lui doit 2 sous 1 denier et il garde à celui-ci une chemise d'homme; Item, Nicod de la Raspa lui doit 6 deniers et Rolet de la Raspa lui garde une vache rouge mote (aux cornes mottues); Item, Mermet Galeis lui doit 5 deniers; Lui-même doit à Gir Forneir, du Bourg, de Moudon, 4 sous 2 deniers.")
(Comments on the AC Moudon's description of the original of this item : The name of the family in Fn 308 is clearly written Molliar, not Malliar. The reference to Chavanes-sur-Moudon may be incorrect, as there seems to be in Fn 307-310, in addition to the village of Cabanis or Chavanes supra Meldunum, a separate place called Cabana Mistralis Supra Meldunum, whose lieu-dits appear to differ. The name shown in the AC Moudon inventory as Uldric Picz is rendered here as Uldricus Pitet – in other words, the abbreviated name written as picz or pitz was correctly resolved by the copyist in Fn 308 as Pitet, but was missed by the AC Moudon. The passage for Michel ffeu Reynier de Reyvro is written in Fn 308 as Michael filius quondam Meynerii (not Reynier or similar) de Reyuro.)

336 Cono de Vuilliens auriga nunc morans Melduni et Johanneta eius uxor, testament, many bequests, mention Perretus brother of Cono, niece Perreta filie ou Tixet de Vuilliens, Stephaneta sister of Cono, Roleta daughter of Johanneta (evidently by another husband ?), 15 jan 1343, recorded by Johannodus Arma clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lvi)

338v Roletus filius quondam Rolerii Balestarii burgensis de Melduno (is this Arbalestier ?), testament, heir his brother Aymo, mention his wife Agnelleta, 26 jun 1349, recorded by Perrodus de Combremont clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lvii)

340 Stephanus filius quondam Mermeti dicti Grusat burgensis de Melduno, testament, universal heirs his brother Lambertus and his sister Agnelleta, bequest to his aunt Nicola uxor Johannodi dicti Rayserot, domum meam cum orto sito retro sitam et situm in Malo Burgo prope domum liberorum Berthodi Sarraceni, but only after the deaths of his brother and sister, various bequests, 06 apr 1349, recorded by Johannes Thorenchii de Melduno clericus et notarius, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lviii)

342 Alexia uxor Aymonis de Prez burgensis de Melduno, bequest, her children Johannes, Roletus, Francesia, et Perrissona, religious and individual bequests, 20 may 1349, recorded by Cono Raficel de Melduno clericus, and copied after his death by Johannes Roberti de Cussey clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lix)

343v Mermetus filius dicte Rossa de Melduno, testament, universal heir his brother Johannes, religious and individual bequests, datum in vigilia Beati Georgii 1349, recorded by Cono Raficel clericus, and copied after his death by Dominus Rodulphus de Cussey de Altavilla, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lx)

346 Nicolaus dictus Rabot presbiter, testament, mention his brother Johannes dictus Rabot, brother Perretus Rabot, various religious and individual bequests, 06 oct 1344, recorded by Johannes Thorenchii de Melduno clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lxi)

348v Johannes dictus Greschon de Grangiis supra Meldunum, testament, all his estate to the hospital, executor Dominus Jacobus Vioneti curatus de Dompono Martino, 03 mar 1349, recorded by Cono Raficel de Melduno clericus, and copied after his death by Johannes Roberti de Cussey clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lxii)

349v Girardus de Fruencia clericus, testament, all his estate to the hospital, datum in crastino festi Beati Petri in Cathedra 1348, recorded by Cono Raficel clericus, and copied after his death by Johannes Roberti de Cussey clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lxiii)

351 Dompnus Voutherius (Vouterius) frater Domini Jacobi Geneveis de Melduno, notice of their joint testament, his heirs Johannes and Henrieta children of his late brother Johannodus Geneveys, numerous individual and religious bequests, bequest to Perrissona mother of Perretus, illegitimate son of his brother Dominus Jacobus, bequest to his daughter Agneleta, 10 may 1349, recorded by Perrodus de Combremont clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lxiv)

353v Stephanus dictus Estui ?, testament, various bequests, 02 jun 1349, recorded by Cono Raficel clericus, and copied after his death by Dominus Rodulphus de Cussey curatus de Altavilla clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : C. lxv)
