There is no title page, but what appears to be the flyleaf shows, at the top, the paper partly worn away, *Secundus Liber Licterarum...*, followed by the beginnings of a rough repertorium, with only a few folio numbers filled in (“Et in isto libero continentur villagia sequencia, primo, Bussy – tertio folio huius libri”), but in the right margin of this page, *Quartus Liber*. In effect, this is part of a multi-volume inventory or digest of the documents in possession of the hospital at some point in the 15th or possibly the early 16th Century, establishing the right and title to various rents and properties. It was apparently intended as the second volume of a set, but this set was later treated as a continuation of a previous set of two volumes, so it was at once the second and the fourth volume.

The foliation shows a similar ambiguity. The first folio after the presumed flyleaf recounts a donation of a chapel to be constructed in Syens in honor of Saint Donatus, dated 26 oct 1397, recorded by Johannes Serracem, the original of which is noted to be in a wooden case with other letters pertaining to the hospital. This folio is not numbered (but Quartus Liber appears at the top); however, the ACV has designated this as folio 1. The second folio, which appears to be much older (more faded, the script earlier and well ornamented, and consistent with the pages that follow, a much more formal arrangement), bears the original folio number 258 (ii^Clviii), and the individual items bear sequence numbers in the left margin, beginning with the format B M prima, later simplified to M followed by a sequence number in Roman numerals, ending with “pro copia” and the signature and paraphe of Uldriodus Guilly. (The M turns out to belong to a sequence of bundles of one hundred documents each, as described below, fol. 341.) At the bottom of this folio (originally 258) there is another folio number in the lower left corner, i (i.e., 1). In the center of the lower margin of the same folio, in pencil, is the recent ACV folio number 2. The three foliation sequences become more discrepant with the accumulation of numbering errors. For example, fol. 272 in the original sequence is unnumbered in the second foliation sequence, but the sequence resumes on the next folio. Then, at fol. 276, the second folio number xvii is repeated. Later, the second folio number xxxi is also repeated. We elected to follow the original foliation, beginning with folio 258.

In fact, the preceding volume (of which Fn 310 is the *Secundus Liber*) is clearly the one now catalogued as Fn 309, at the end of which, on fol. 241, we find a pencil notation dated July, 1939, in the hand of R. C. (Raoul Campiche) : “Les folios 242 à 257 étant en blanc, et à demi pourris, n’ont pas été conservés.” The repertoire of Fn 309 was too far gone to conserve as well, and the first part of it, 7 folios in all, was reconstructed by the ACV by extracting the required information from the text (including dates), with the (modern) title, *Répertoire des Tomes III et IV*. This section of Fn 309 is followed by the remaining 9 folios of the original repertorium, the contents of which clearly show that Fn 309 and Fn 310 form one continuous sequence. Fn 307

and Fn 308 form a similar sequence, the repertorium in Fn 307, and the foliation continuing from Fn 307 into Fn 308. Thus, the repertorium in Fn 309 is the key to locating records in Fn 310, but we have extracted Fn 310 directly, as the entries in the Fn 309 repertorium are sometimes difficult to read.

The material that had been organized by hundreds into bundles ends with the item on fol. 424. From fols. 426 to the end, fol. 481v, the material seems to consist of newer items that were not yet organized in that way, grouped by the notary who recorded them. Further analysis of Fn 307-310 might reveal more about the organization of the archives of the hospital.

Flyleaf 2 Evidently a later insertion (but earlier than the rough repertorium on Flyleaf 1), foundation of the chapel of Sanctus Donatus, 26 oct 1397, Dominus Jacobus Cossenay curatus perrochialis ecclesie de Siens, accepts a donation by Anthonius Bruyvaul clericus de Melduno (he was the commissaire for a number of terriers) and others who may wish to join him, to endow the chapel, near the farm ou Pollant at the discretion of the said Anthonius, with the (copied ?) signature of Johannes Sarracem, with a notation in the same hand, that the original document is in a wooden box with others in favor of the hospital. The verso of this folio is also blank.

258 (Second foliation sequence, in the bottom left corner, begins here, i. However, if we follow the list on Flyleaf 1, this is indeed the “third folio”, where the section for Bussy begins, and this is also, for the purposes of the ACV, fol. 2. Therefore, this folio is at once, 258, i, ACV 2, and “third folio”. We find it most reasonable to follow the original foliation.) Lictere de Bussy

nostrarum et Ancillione matris nostris et Mermete uxoris mee dicti Jacobi antenati et Annelete uxoris mee dicti Jacobi Bersar et Girardi fratris nostri ac eciam Perreti alumpni mei dicti Jacobi antenati, recorded by Johannes Roberti de Cussey clericus qui post obitum Cononis Raficel de Melduno clerici had possession of the registers of the said late Cono, pro copia, with signature and paraphe of Uldriodus Guilly. 259v Nicola relicta Johannis Codat (or Codar ?, but later in the text, apparently Cordat) de Bussy, 04 may 1349, abstract of testament, donation to the hospital, heirs mentioned but not named, original testament recorded by Cono Raficel de Melduno and copied after his death by Dominus Rodulphus de Cussey curatus de Altavilla, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M iiiii)

260 Mermetus dictus Cordat ? de Bussy burgensis de Melduno, die Lune post festum concepcionis Beati Marie Virginis 1384, testament, donation to the hospital, to be paid by his son and heir Johannes Codat, recorded by Nicolaus Cordeir clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M v)

260v Johannes et Mermetus liberi Cononis de Bussy, 04 may 1349, donation to the hospital pro remedio et salute animarum Perrusone uxoris mei dicti Johannis, et Nicole uxoris mee dicti Mermeti, recorded by Cono Raficel de Melduno clericus, and after his death copied by Johannes Roberti de Cussey clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M vi)

261 Ysabella filia Mermeti Brunyer de Bussy quondam dicte Mora, 28 aug 1360, abstract of testament, donation to the hospital, heir Perreta amica ? mea filia quondam Reymondi Pastoris de Bussy, lacks signature and paraphe but otherwise conforms with the other items in the sequence. (Margin : M vii)

261v Agnes filis Johannodi Mossu burgensis de Melduno uxor Johannis Nicola de Bussi, 21 sep 1378, abstract of testament, donation to the hospital, heirs mentioned but not named, recorded by Johannes de Vallacrest clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M viii)

261v Perrodus Chapalet de Bressona commorans apud Bussy, ?? july 1385, owes cense to the hospital, whose rector is Johannes Landri clericus de Melduno, secured by various properties, recorded by Johannes de Vallacrest clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M ix)

262v Jaquinodus de Bussy, 08 nov 1400, abstract of testament, donation to the hospital, recorded by Anthonius de Stagno clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M x)

262v Ysabella filia quondam Perrodi Clot de Profondavalle relicta Jaquinodi de Bussy, 22 jan 1400, abstract of testament, donation to the hospital, recorded by Anthonius de Stagno clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xi)

263 Humbertus Recagnioz de Bussy prope Meldunum, 20 mar 1409, abstract of testament, heir Petrus his nephew, son of the late Johannodus Recagnioz de Bussy his brother, donation to the hospital, recorded by Franciscus Champagnio clericus de Yverduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xii)

263v Johannes Bauz filius Vuilliermi de Bevouges et Ceciliona eius uxor, in crastino Beati Illarii 1348, sale of property to Aubertus dictus Cona ? (see next item, where he is Conaz, but elsewhere the name is clearly written Cova) on which they owe cense to the hospital (in effect, a mortgage ?), recorded by Cono Raficel and copied after his death by Johannes Roberti de Cussey clericus, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xiii)

264v Aubertus dictus Conaz (=Cova) burgensis de Melduno, 13 mar 1349, donation to the hospital pro remedio anime mee et anime quondam uxoris mee, recorded by Girardus Choupar clericus de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xivii)

265 Girardus Arma de Melduno presbiter rector confratrici Concepcionis Beati Marie Virginis de Melduno, 11 nov 1365, whereas Stephanus Juscivel de Bussy owes cense to the said confratrici on a property held jointly with Gioldus Bevoujat, I the said rector promise to defend their title, especially against Vuillermus Domeneget and his heirs, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xv) In cuius lictere dorso describitur prout ecce Stephanus Juscivel in predicti lictera contentus dimictit pro se et suis heredibus perpetue hospitali Beate Marie de Melduno censuam intra contentam, dated 04 apr 1367 (datum quarta die aprilis anno xlse lxseptimo).

266 Nycodus filius quondam Jaqueti Nycolaz de Bussy with approval of his wife Johanneta, 20 dec 1457, sale to Nycodus Bussy burgensis Melduni rector et rectorio nomine hospitalis pauperum Beate Marie Virginis de Melduno, cense, fiances Johannes de Costel alias Bellas de Cabanis supra Meldunum and Petrus Ensis (=Espaz) notarius subscriptus, no signature or paraphe. (Marginal notation at the bottom of the preceding page : M xvi, possibly intended to apply to this item.)

267 Rodulphus dominus de Langino miles et Katherina filia Nobilis viri quondam Domini (inserted in the margin : Aymonis domini) de Bossonens militis cum laude et auctoritate Johannis de Blonay domicelli mariti mei dicte Katherine, 10 dec 1378, sale to Perretus Pudraux rector hospitalis pauperum Beate Marie Virginis de Melduno, cense of 100 sols, fiances Richardus de Vuilliens domicellus and Johannes Mistralis Lustriaci, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xvii) (The father of this Katherina was Amedeus de Vulliens, from other sources.)

269 Richardus de Prez miles filius quondam Stephani de Prez domicelli, 14 feb 1344, abstract of testament, donation to the hospital, tota decima mea ville de Mont supra Warmarens, with

consent and approval of Domina Bonarem his wife, seals of Anthonius Cornuz de Vuilliens *miles ballivus Vuaudi* and the said Richardus and Bonarem mentioned, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xviii) (The original of this document has not been located in the inventory of the ACV by searching for an entry matching the date. However, it may be the item in the Archives Communales de Moudon M 58, 233, Legs, Hôpital de la Vierge-Marie, Richard de Prez, chevalier, fils de feu Estienne de Prez, donzel, lègue à l'hôpital de la Vierge-Marie, de Moudon, sa dîme de Mont sur Vuarmarens, 14 feb 1344/1345. If this is not a copy, it may have the impressions of the seals mentioned above.)

270 Petrus Ogueis, Anthonius Barat ? (or possibly Varat, the script is ambiguous), Vuillermus Malliar de Brenles, 19 nat 1417, whereas Franciscus Champagnioz rector of the hospital made an accusation of the Grangia of the hospital at Villar Blegie to Jaquetus Bayer, Johannes Bride ?, Vuillermus Burder, Petrus Blam, Nicodus Nillier, and Petrus Alamand de Brenles, now the said reconnaissants acknowledge the said cense, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xix)

270v Johanneta relicta Conodi Carrel de Cabanis supra Meldunum, 29 jun 1418, abstract of nuncupative testament, universal heirs her daughters Anthonia and Guilliona by her late husband Conodus (but he is also called, by metathesis later in the text, Nicodus), donation to the hospital, secured by property, one parcel at Chavannes with neighboring tenants Nicodus Very and Johannes Moctet, recorded by Anthonius de Stagno clericus de Melduno and copied after his death by Jaquetus Quoquerel notarius de Melduno, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xx)

271v Petrus Girardi de Ursy, 21 jul 1433, sale to Jaquetus Quoquerel notarius et burgensis de Melduno rector hospitalis pauperum Beate Marie Virginis de Melduno, cense, fiances his brother Anthonius Girardi de Vuarmarens, and Petrus and Nicodus Cons, brothers, of Vuarmarens ? (dicti loci), pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xxi)

280 Rodulphus filius quondam Humberti de Chavanes supra Meldunum, Jaqueta eius uxor, et Johannodus filius eorum, die Martis post festum Beate Luce Evvangeliste 1321, sale to Dominus Jordanus sacerdos de Melduno, cense on various properties at Chavannes, neighboring tenants include : Girordus his brother, Johannes de la Cor (Cort), and the de Tecto family, fiance Girordus de Chavanes filius quondam Humberti frater meus dicti Rodulphi, pro copia, with signature and paraphe of Uldriodus Guilly. (Margin : M xxx)

The testament of Marguerita, the first ? wife of Jaquetus Quoquerel, is mentioned in Fn 309, fol. 59v, I lxi, and the original is AC Moudon, M 58, 989, 23 mar 1409. We found no other mention of Johanneta.)

475v Humbertus de Glana dominus de Cugiez, 25 jun 1450, sale to Anthonius Guilly burgensis de Melduno rector et rectorio nomine hospitalis pauperum Beate Marie Virginis de Melduno, et hoc de laude, consilio, et mandato Glaudii de Curia burgensis et procuratoris ville predicte de Melduno, cense, recorded by Jacobus Pini clericus de Melduno, with appropriate closing formalities, but lacks signature and paraphe. (No marginal sequence number)

(No marginal sequence number. Folio reinforced with paper at the margins, on which the notation in pencil, apparently from the restoration of 1939 : fin du volume. There is, however, no indication in the text itself nor in the repertorium in Fn 309 that the volume Fn 310 should or originally did end here, and it is possible that additional folios might have been lost.)
