

ACV Fn 352 partial terrier for Jean de Villarzel, commissaire Denis Pivard.

Volume begins at fol. 122, a section concerning Syens. Flyleaf appears to indicate that the first section, possibly relating to Chavannes-sur-Moudon, has been detached. There is no index in this volume, but it is possible an index is or was included in the detached section. The preceding terrier was compiled by Eg. François Collomb.

122 François filz de Loys Mottaz de Siens, 15 dec 1613. Property previously recognized (Fr. Collomb) by Pierre filz de feu Henry Mottaz and by François filz de Loys Mottaz of Siens, and before that (Jehan Luisy) by Pierre Mottaz.

126 Pierre Mottaz, 16 dec 1613. Property previously recognized (Fr. Collomb) by Pierre filz de feu Henry Mottaz and by François filz de feu Loys Mottaz, and before that (J. Luisy) by Pierre filz d'Henry Mottaz. Also property previously recognized (Fr. Collomb) by ledict feu Pierre filz de Henry Mottaz, and before that (J. Luisy) by Noble François de Marcello autrement Charthey, etc.

132 Jehan filz de Thomas Rey de Siens, 16 dec 1613. Property previously recognized (Fr. Collomb) by Pierre filz de feu Henry Mottaz and by François filz de Loys Mottaz etc., audict recognoissant advenus et appartenans par heritage et succession de « Maurise » sa deffuncte mere qu'estoit fille de feu Humbert Mottaz. Also property previously recognized (Fr. Collomb) by François filz de feu Loys Mottaz etc., audict recognoissant advenus et appartenans par heritage et succession de ladicte deffuncte « Marie » Mottaz sa mere predicte.

137 Pierre Porchet dict Gagnens de Siens, 16 dec 1613. Similar to above, from the Mottaz, and purchased from them by his predecessors. Also property previously recognized (Fr. Collomb) by Antoine Vesin cordonnier et bourgeois de Moudon, and before that (J. Luisy) by Noble François de Marcello alias Charthey, purchased by his predecessors. Also property recognized (Fr. Collomb) by Loys Porterat and by Jehan Porterat, and before that by Fr. de Marcello alias Charthey.

143 François Porchet, 16 dec 1613. Previously recognized (Fr. Collomb) by Claude Pitton bourgeois de Frybourg, and before that (J. Luisy) by Fr. de Marcello, acquired through the discution des biens de Claude Porchet.

146v Jacques Baz (? or Raz ? Naz ?), 16 dec 1613. Property from the Mottaz as above, by acquis cy devant faict de Catherine fille de feu Jehan Mottaz de Jehan Girod et de Pierre Pechoux (rec. Jacques du Toict notaire 07 dec 1611).

150 Pierre filz de Jacques Martin de Siens, 16 dec 1613. Property from Claude Pitton, as above, by purchase.

155 Jacques filz de feu Pierre Fauchierres de Bussy, 12 jan 1614. Property previously recognized (Fr. Collomb) by Jehan filz de feu Pierre Fauchieres, and before that (J. Luisy) by

ledict Pierre Fauchierres, by partage with Pierre, Noel, Jehan, et Jacques filz de feu François Fauchierres ses nepveux. Also property previously recognized (Fr. Collomb) by feu André Jordan alias Wagnieres and before that (Luisy) by feu Claude Jordan alias Wagnieres père dudict André Jordan.

162 François Perrin de Villard le Comte au nom de Pernon Fauchierre sa femme fille de feu Jehannod Fauchieres, 02 jun 1613. Property previously recognized (Fr. Collomb) by Jehan filz de feuz Pierre Fauchierres, and before that (J. Luisy) by ledict feu Pierre Fauchierres, and to the said Pernon by paternal succession. Also property previously recognized (Fr. Collomb) by feu Pierre Demont and his nephew Anthoine Demont, and before that (J. Luisy) by ledict Pierre Demont.

166v Pierre, Noel, Jehan, et Jacques enfans de feu François Fauchieres, 11 jan 1614. Property previously recognized (Fr. Collomb) by feu Fauchieres, and before that (J. Luisy) by feu Pierre Fauchiere son pere, à eulx advenus par partage faict avecq Jacques filz de feu Pierre Fauchieres leur oncle. Etc.

172v Pierre filz de Thomas Jordan de Bussy, 06 apr 1613.. Property previously recognized (Fr. Collomb) by feu André Joran alias Wagnieres, and before that (J. Luisy) by feu Claude Jordan son pere, by paternal succession.

176 Jacques filz de François Wagnieres de Bussy, 06 apr 1613. Property previously recognized (Fr. Collomb) by feu Jehan Fauchieres, and before that (J. Luisy) by feu Pierre Fauchierres son pere, by purchase from Jehan Fauchierre.

179v Jacques Jossivel de Bussy, 02 jun 1613. Property previously recognized (Fr. Collomb) by feu Jehan Jossivel, and before that (Luisy) by feu Estivent Joseeivel son pere, audict confessant devenuz par legitime succession paternelle. Also property previously recognized (Fr. Collomb) by feu Pierre Demont cordanier de Moudon tant à son nom que de Antoine Demont son nepveux, by an abbergement anciennement faict à ses predecesseurs par ledict Pierre Demont.

187v Jehan Frossard au nom de Marie Jossivel sa femme, 02 jun 1613. Property previously recognized (Fr. Collomb) by feu Pierre et Antoine Demont, and before that (J. Luisy) by the said feu Pierre Demont en faveur dudict Manifficque Seigneur Aymé de Geneve Seigneur de Lullin et de Wlliens, à ladicte Marie Jossivel devenuz par succession paternelle et à ses predecesseurs par abbergement des Demont.

193v Pierre filz de feu Estievent qu'estoit filz de feu François Jossivel faicte par Egrege Gaspard Jossivel son oncle et tuteur, 02 jun 1613. Property previously recognized (Fr. Collomb and previously by J. Luisy) by feu Pierre Demont tant à son nome que de Antoine Demont son nepveu, by inheritance from his predecessors and by abbergement from the said Demonts.

201 Daniel Pahuz filz de feu Jacques Pahuz mistral de Thierrens, 16 jun 1613. Previously recognized (Fr. Collomb) by Loys Pahuz, and before that (J. Luisy) by feu Claude Contoz. Audict confessant devenuz par retraction de proximité de Christophle Favre qui l'avoit acquis de François Pahuz.

204v Joseph filz de feu Humbert Forestey de Thierrens, 21 jun 1613. Property previously recognized (Fr. Collomb) by François filz de feu Benoit Forestey, and before that by feu Antoine Forestey son oncle, by succession paternelle.
