

ACV Fn 5 bis Fiefs of Vulliens, for Richardus de Wlliens, commissaire Robertus de Bons, 1385-1388

The purpose of this small terrier is explained on the first folio, in Gothic block letters: “Sequentur extente et recogniciones viri Nobilis Richardi de Wlliens filii Nobilis Domini Rodulphi de Wlliens militis quondam de rebus, censibuz, redditibuz, hominibus, abberg..., usagiis, tributis, et ceteris aliis juribus quibuscumque quas ... ipse Richardus habet, percipit, possidet, atque tenet in villagiis de Messeres, de Quarrogio, et ceteris loci et villagiis tocius Waudi infrascriptis et in territoriis, finagiis, et confinibus eorundem, fatte et recite per me Robertum de Bons de Clusis civem Gebennis diocesis notarium publicum imperiali auctoritate et juratum curie baillivatus Waudi deputatum ... ad dictas extentas recipirandas per Discretum virum Aymonem Mercerii commissarium generalum terre Waudi ... manu mea propria scripte et signo in fide solito uncum subscriptione nominis mei fideliter ... que quidam extentem et recogniciones fuerunt incepte et ... per me dictum Robertum die vicesimasecunda mensis Marcii anno domini millicimo tercentesimo octuagesimo quinto...” (22 mar 1385).

There is a partial repertorium covering fols. 1-15 only, likely dating from the 16th Century or even later.

The dates are likely Style of the Annunciation, as may be surmised from the long cluster of dates in March, 1385 and April, 1386, with nothing between.
