

ACV Fn 6 Extracts of documents belonging to churches of Vulliens, Syens, and certain chapels and confréries at Moudon, 1364-1518

The script is messy and sometimes very careless, probably from the late 16th Century. The main interest is a reconnaissance by Johannes de Blonay, son of the late Johannes de Blonay and Catherine de Vulliens, fol. 34, but many families are represented here, from a very wide area. The volume is bound in a copy of the antiphon *De Jherusalem exeunt reliquie et salvacio*, which might have been used for the dedication of a church. A large number of the documents included in Fn 6 seem to have been part of the “Nouveaux Titres” inventory of the ACV, and the originals of at least some of them are now found in CC XX 302, the collection of miscellaneous documents for the commune of Vulliens.

1 Johanneta fillia quondam Jacoz de la Raspaz parrochie de Siens relictum Anthonii Crousaz de Vulliens, bequest to the parish church (St. Stephen) of Vulliens, to be paid by her daughter Francisca, 08 nov 1572 (clearly written, but also clearly an error, as the document would not have been in Latin at that late date ; the corresponding testament is found in the Nouveaux Titres inventory, ACV C XXII NF16444, 08 nov 1472, “Testament de Jeannette Veuve de feu Antoine Crousaz, de Vuillens: légué à l'église de Vuillens, en fondation de 4 messes annuelles, 4 s de rente, assignés sur tous ses biens, & rachetables de 4 lb: héritière universelle sa fille Françoise, femme de Pierre Rolaz”, the original of this document is apparently C XX 302/35), “signé Johannes Joliveti” (known dates for the important notary and châtelain de Moudon of this name range from 1416 to 1453 and possibly as late as 1455, but there was another Johannes Joliveti, clericus de Melduno, in the next generation, as late as 1474).

1v Johanneta fillia Johannis Nycod antenati de Vulliens, reconnaissance for debt, 20 jan 1465, “signé Johannes Bagnion”.

1v Petrus Belchat de Vullienjaux, reconnaissance for debt to Dominus Anthonius Arma curatus de Vulliens, 02 dec 1401.

2 Anthonia relicita quondam Nyctodi Thonney de Vulliens tamque (=tanquam) tutrix et administratrix et eo nomine liberorum meorum et dicti quondam Nyctodi Tonney, 05 mar 1450 ?, “signé Jacobus Monachi”.

2 Anthonia relicta quondam Anthonii Tonney de Vulliens tanquam tutrix et administratrix liberorum meorum, 15 mar 1450, “signé Monachon”. (Possibly another copy of the previous item. The originals of both are likely C XX 302/10 and 11, both dated **15 mar 1450**.)

2v Anthonius Morel d’Escublens perrochie de Promasens, reconnaissance of debt to the church, 22 jan 1465.

3 Nycodus Ansonet ? de Rospraz, bequest, 21 jan 1465, “signé Johannes Bagnyon”.

3 Johannes Cueti curatus et rector perrochialis eclesie de Vulliens et eo nomine, quod cum Johannes Chastellain recognoverit pro se et suis se debere et legittime solvere tenere..., datum ut supra (=21 jan 1465 ?).

3v Anthonius Racagnyouz de Vulliens, debt, 13 jun 1468, “signé Bagnyon”.

3v Johanneta relicta Anthonii Bugniat alias Crousaz et Perrissonaz uxor Nicodi Chappuis sorores, bequest, 21 ? jan 1465.

4 Stephanus Nycod de Vulliens antenatus, sale of cense, 22 jan 1465, “signata ut supra”.

4v Johannes Cueti curatus et rector eclesie de Vulliens et eo nomine, quond cum Johannes Burdin de Vulliens made a donation, promise to pay, 19 jan 1465, “signé ledict Bagnyon”.

4v Anthonius Boverii (clear) de Vullienjaux, reconnaissance, 22 jan 1465, “signé Jehan Bagnyon”.

5v Jaqueta fillia quondam Mermeti Fuseir de Escublens relicta Perronet Bouvyer alias Nycod de Vulliens, donation, 04 aug 1450, “signé Guilly”.

6 Johannes Bublex alias Rod de Vulliens, bequest, 01 sep 1423, “signé Anthonius Guilly”.

6 Johannes Nycod junior de Vulliens, reconnaissance, 19 jan 1465, “signatum per Johannem Bagnyon”.

6v Anthonius Oddet alias Burdet de Vulliens, reconnaissance, 21 jan 1465, “signé Bagnion”.

6v Andreas Bezenon de Rospraz perrochie de Vulliens, reconnaissance, 11 jan 1465, “signé Johannes Bagnyon”.

7 Johannes Paccoton filius quondam Johannis Pacoton de Rospraz perrochie de Vulliens, reconnaissance, 21 jan 1465, “signé Johannes Bagnyon”.

7 Nycodus Brunat de Rospraz perrochie de Vulliens, reconnaissance, 21 jan 1465 (die et anno quo supra), “signé ledict Bagnyon”.

7v Johannes Cueti curatus et rector perrochialis de Vulliens et eo nomine, quod cum Johannetta relicta Anthonii Bugnyat alias Crousaz de Vulliens made a reconnaissance, 19 jan 1465, “signé ledict Bagnyon”.

7v Johannes Chastellain filius Johannis Chastellain, reconnaissance, 21 jan 1465, “signé Bagnyon”.

8 Johannes Burdin carpentator de Vulliens, bequest, 19 jan 1465, “signé Bagnyon”.

8 Perronetta uxor Perrodi Charvaz (clear) de Rospraz, reconnaissance, 21 jan 1465, “signé Bagnyon”.

8v Jehannetta relicta Anthonii Bugnyat alias Crousa de Vulliens, reconnaissance, 19 jan 14565, “signé Johannes Bagnyon”.

8v Anthonius Pontier de Vulliens, sale of cense, 10 jun 1426, “signé Guilly”.

9 Guillermus Nardin filius Petri Nardin de Vulliens, reconnaissance, 19 jan 1465, “signé Johannes Bagnyon”.

9v Nycolletus Guilly alias Mottitaz de Tierrens, sale of cense, from a bequest by Marguerita filia Johannis Mottitaz uxor Claudii de Praz dicti loci de Vulliens, 04 mar 1403, “signé Uldriodus Guilly”. (We speculate that the date may be in error, possibly a word omitted in “millesimo quatercentesimo tertio”. The vicar at the time of this transaction was Dompnus Amedeus Rogeti. This speculation turns out to be correct, the item in question is clearly C XXII NF16423, 04 mar **1463**, “Acquis de 12 s de rente (légués par Marguerite Motitaz, femme de Claude de Praz de Vuillens) assignés sur tous les biens du vendeur, fait en faveur de l'église de Vuillens contre Nicolet Guilly autrement Motitaz de Thierrens, - rachetables de 40 s”, and the original is evidently C XX 302/12, with the same date.)

9v Petrus Baconyer de Vulliens, reconnaissance, 07 may 1397, “signé Uldriodus Ysabel”.

10 Franciscus Stiestardin filius quondam Johannis Stiestardin notarii et burgensis de Lylaz, quod cum Johannes Stiestardin pater meus legaverit perrochiali eclesie de Chabie seu curato eiusdem, sale to Guillermus de Vulpillieres curatus de Chabie, 13 nov 1503, “signé Symonis”. (The information here is correct. The original is C XX 62/58, described under C XXII NF12916, the surname rendered as Stiestartin.)

10v Perrisonna relicta Aymoneti Borchar ? (or Beichar ?) de Vulliens aut Petrus filius dicti quondam Aymoneti, quod dictus Aymonetus dedit et legavit curato de Vulliens, 27 oct 1364, “signé Perrodus de Siens”.

11 Jaquetus de Mossel de Vulliens, debt to Dominus Anthonius Jayet de Melduno curatus perrochialis eclesie de Vulliens, 29 dec 1431, “signé Jaquetus Malle”.

11 Nycolleta fillia quondam Claudii Perdonnet relictा Nycodi Chappuis de Rospraz, bequest, 20 aug 1476, “signé Claudius Gaule”.

11 Stephanus de Corniat ? (script rather ambiguous, but written apparently Co^rniat) de Vulliens, quod cum Petrus fillius meus et uxor mee filie quondam Vulliermi Bublex de Vulliens dederunt eclesie de Vulliens, 12 deniers cense. Item, cum Agnelleta quondam uxor mea dedit et legavit predicte eclesie de Vulliens 12 deniers..., 13 jan 1372, “signé Perrodus de Siens”. (C XX 302/3)

11v Petrus Pontier alias Jaquerel de Vulliens et Perronetta eius uxor, reconnaissance for Anthonius Arma curatus eclesie de Vulliens, 11 jun 1401, “signé Franciscus Champagnyon”.

12 Johannes Fornay clericus et Agnes eius uxor, reconnaissance for Girardus Arma curatus de Vulliens, 12 oct 1388, “signé Uldriodus Ysabel”.

12 Venerabilis vir Nycodus Constantine ? vicarius de Vulliens, bequest, 26 aug 1507, “signé Guillermus Cornu”.

12v Berthodi (should be Berthodus) Lovat de Vulliens et Agatha eius uxor, quod cum Aymonetus Minard de Vulliens dederit eclesie de Vulliens..., 11 oct 1369, “signé Willermus ? Chartreir”.

13v Johannes Cour alias Jacoullaz morans apud Mollens (=Morlens), reconnaissance for Nycodus Bechat de Vulliensjaux, videlicet literam matrimonii celebrati inter me dictum Johannem et Henrietam uxorem meam sororemque dicti Nycodi per integra satisfactionem, quictavi et quicto fratrem, 06 aug 1427, “signé Jehan Crespy”.

13v Claudius Crousaz de Hermenges, reconnaissance for Anthonius Lamberti curatus de Syens, die Lune post festum Conversionis Sancti Pauli 1477, “signé Jacobus de Bulo”.

14 Johannes Porterat de Syens, sale to Humbertus Clot de Bressonaz et Guillermus Mottaz de Syens veluti scindici et gubernatores perrochie de Syens nomine et ad opus confratrie Virginis Marie de Siens, cense, 25 jun 1420, “signé Rodulphus de Mont”.

16 Johannes filius quondam Petri Jaulignin de Villarzel l'Evesque, reconnaissance for Venerabilis vir Dominus Claudius Sapientis tanquam altarense et rector nomine altaris seu cappellanye fondate in ecclesia perrochiali Beati Stephani de Melduno in honori omnipotens Dei et Beati Martini Episcopi et Confessoris, 06 jun 1489, “signé Jehanne Rodi”.

17v Guilliermus Guydroz clericus de Villarzel l'Evesque filius quondam Johannis Guydroz filius quondam Perrodi Guydroz dicti loci de Villarzel, reconnaissance for Discretus vir Dominus Jacobus Viguerat cappellanus rector et rectorio nomine altaris Beati Martini fondati infra ecclesiam perrochialem Beati Stephani de Melduno, 05 ? mar 1460, “signé Petermanus Burichet”.

18v Petrus filius quondam ~~Johani~~ Serven ? de Sancto Martino Quercus, reconnaissance for Dominus Johannes Combremondi de Melduno presbiter rector altaris Sancti Martini in ecclesia perrochiali de Melduno, 08 may 1435, “signé Jaquetus Malle”.

19v Claudius Sapientis capellanus rector altaris Sancti Martini in ecclesia perrochiali Sancti Stephani de Melduno fondata, quod cum Anthonius filius quondam Mermeti Mermet alias de Marnant et Petrus filius quondam Vulliermi Mermoz de Granges mihi perpetue debere et solvere confessi fuerunt, reconnaissance, (information about the foundation of that chapel by Johannes Malliard), 06 dec 1478, “signé Andreas Nycodi”.

20v Girardus Butet textor de Melduno, reconnaissance for Discretus vir Dominus Jacobus Viguerat cappellanus rector altaris Sancti Martini in ecclesia perrochiali Beati Stephani de Melduno fondate, 07 jun 1454, “signé Petrus Ensis”.

21v Johannes Paschon tutor filius quondam Stephani Paschon burgensis de Melduno et Ysabella eius uxor filia quondam Jaqueti Vaulerii ?, reconnaissance for Dominus Johannes Combremondi presbiter de Melduno rector altaris Sancti Martini, 27 oct 1437, “signé Anthonius Crostelli”. (Described as C XXII NF13748, original is apparently C XX 207/165.)

22 Roletus dictus Fourat ? douz Chasnoz, quod ego nomine Johannete et Margueritte filiarum mearum, sale to Dominus Johannes Malliard de Melduno presbiter, cense, 04 jul 1398, “signé Vulliermus de Ogens”.

22v Nychodus filius Johannerii Barbey de Villarzel et Perreta filia quondam Perrodi de Alamagny de Granges, sale to Dominus Johannes Maliar capellanus de Melduno, cense, 28 jun 1395, “signé Johannes Vannerii”.

23 Fransciscus Jueneti ? (written apparently ju^eneti) cappellanus de Paterniaco rector modernnis ? altaris Sancti Martini, quod cum Jacobus Vualacrest burgensis de Melduno pro se etc. mihi pro me etc. vendiderit census, 20 may 1442, “signé Anthonius Crostelli”.

24 Jacobus Vualacrest filius quondam Johannis Vualacrest clericus et burgensis de Melduno, sale to Dominus Fransciscus Jullieti capellanus de Paterniaco rector moderno altaris Sancti Martini, several censes owed by others, 20 may 1442, “signé Anthonius Crostelli”.

25 Cladius Cordey de Capellaz Vauldannaz, quod cum Roletus de Buloz et Amedeus Cordey sold to Venerabilis vir Dominus Petrus Brideti rector cappeli Sancti Martini, cense, die Sabbati ante Dominicam Ramispermaris (=Ramis Palmaris) 1507, “signé Aymonis de Vallone”.

25 Roletus de Buloz de Neyrieulx perrochie de Thierrens, sale of cense to Dominus Petrus Brideti cappellanus Lausanne altariste altaris ad laudem Dei et honorem Beati Martini, 15 mar 1500, “signé Cladius Porteri”.

(There is a collection in the AC Moudon that likely pertains to this section, AMF 2 Clergé, Chappelle de la Conception, reconnaissances diverses, 1448-1586, not described further, but plausibly containing the original documents extracted below.)

35 Item, cum prememorata dicta Catherina de authoritate prefati Domini Johannis quondam de Blonay militis eius viri assignavit et assectavit dicte confitente (should be confratrie) et rectori eiusdem decem solidos Lausannenses census pro medietate viginti librarum Lausannensium dicte confratrie legatarum per quondam Nobilem virum Dominum Anthonii Cornuz de Vulliens militem. (Presumably, the obligation of Catherina arises from the estate of her grandfather Anthonius de Vulliens the younger, shared with her uncle Petrus, son of Anthonius the younger. Can the original bequest of 20 livres, from the cense stated here financed at 5% simple interest, be located?)

Item, et quinque solidos Lausannenses census pro centum solidorum (again, 5% simple interest, in this case on a principal of 100 sols $\div 20 = 5$ livres) in quibus dicta Margueritta eius mater (this should be Marguerita de Grandimonte, mother of the Johannes de Blonay who married Catherina de Vulliens ; however, Nicodus or Nicolaus de Blonay had married as his second wife, Marguerita de Vulliens, daughter of Anthonius de Vulliens the elder, who was thus the step-mother of Johannes de Blonay) dicte confratrie tenebatur cum Petro de Vulliens predictis legatis predecessorum suorum, quos quindecim solidos census predictos (the two censes mentioned above, 10 + 5 sols) eadem dicta Catherina pro se et suis heredibus promisit juramento suo etc. et sub obligacione omnium bonorum suorum solvere et reddere dicte confratrie et rectoribus eiusdem perpetue annuatim termino predicto, prout in lictera inde confecta per Vuillierum Chartreir clericum de Melduno recepta et signata data 17 apr 1385 plenus continetur. (Note that an additional 5 livres, and 5 sols cense, from the original bequest by Anthonius de Vulliens the younger are not part of Catherina's obligation ; is that cense mentioned elsewhere in Fn 6 ?)

35v Ceterum cum prememorati conjuges Johannes et Catherina dederint dicte confrarie dimidiam libram bone cere nove annui et perpetui redditus census quam dimidiam libram cere promiserint pro se et suis quibus supra juramentis suis ad Sancta Dei Evangelia corporaliter prestitis et sub expressa obligacione omnium bonorum suorum quorumcunque solvere et reddere dicte confrarie seu rectori eiusdem annuatim et perpetue termino predicto, prout continetur in lictera super premissis confecta per Uldriodum Ysabel de Melduno notarium recepta et signata data 13 jan 1405,

(Can the originals or contemporary copies of any of the above instruments be found? Dates 15 dec 1382, 17 apr 1385, 13 jan 1405, 31 jan 1449. None of these were found in the inventories of the ACV nor in the Archives Communales de Moudon. However, they might have been copied into one of the terriers. The only others noted as involving the Confrérie or chapel or altar de la Conception de la Vierge Marie are : Fn 340 (rentier sommaire), 341, 345, and Fn 314 already examined), pour les confréries du Saint-Esprit de Moudon. There may have been other religious bequests by these families, so the rest of the terriers relating to the churches, chapels, hospitals, and similar institutions of Moudon need to be checked. Also: **P Loys 269**, 29 mar 1401, "Richard de Vuilliens, donzel, de Moudon, lègue à la confrérie de la Conception de la Vierge Marie 12 deniers lausannois de cens, payable à chacun de ses anniversaires et rachetable au prix de 20 sous par ses héritiers. Il assigne ce cens sur tous ses biens. Acte reçu et levé par Guillaume Chartreir, clerc, de Moudon, juré du bailliage de Vaud." In Fn 314, for the Confréries du Saint-Esprit de Moudon, fol. 12v, a list of "census antiqui qui forte non solventur", the following entries: Dominus Richardus de Vuilliens, 1 cupam medii frumenti; Nobilis Jaqueta relicta Nobilis Anthonii de Vuilliens (but in fact, his widow was Elyonoda, and Jaqueta was one of his daughters), ii cupas medii frumenti; Nobilis Vuillermus de Vuilliens, ii cupas medii frumenti. The most likely place to find these documents would seem to be AC Moudon, AMF 2 Clergé, Chappelle de la Conception, reconnaissances diverses, 1448-1586, for which, as far as we are aware, there is no published inventory.)

37v Johannes Chapuis alias du Certor morans Melduni, quod cum Stephanus Paschiz morans Melduni confessus fuit quod cum Mermetus Platel quondam morans Melduni, Marguerita eius uxor, et Johannes dicti Mermeti nepos vendiderint perpetue quilibet ipsorum insolidorum quondam Uldriodo Cudeffert rectori altaris confratrie Comceptionis Beate Marie Virginis de Melduno, cense of 6 sols, and Mermetus then sold to Dominus Jacobus Salamyn presbiter Melduno rector of the same, another cense, and Stephanus Paschon promised to pay these to Nycodus Barbey rector of the said altar, now the said Johannes promises to pay, 18 feb 1449.

39v Jacobus filius quondam Uldriodi Ysabel burgensis de Melduno, quod cum quondam Jacobus filius quondam Ysabelle de Paterniaco burgensis de Melduno made a reconnaissance for the confratria, mention of a transaction recorded by Stephanus de Burgo 10 apr 1345, now the saud Jacobus Ysabelle filius quondam Uldriodi Ysabelle make reconnaissance to the rector Jacobus Fabri, 25 feb 1449.
